**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DEPARTMENT OF PUBLIC WORKS TO APPLY FOR, AND ACCEPT, IF AWARDED, FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA CLIMATE INVESTMENT FIRE PREVENTION GRANT PROGRAM**

**WHEREAS**, the Governor of the State of California in cooperation with the California State Legislature has enacted the California Climate Investment initiative, which provides funds to the State of California and its political subdivisions for fire prevention programs; and

**WHEREAS**, the California Department of Forestry and Fire Protection has been delegated responsibility for the administration of the California Climate Investment Fire Prevention Grant Program including, without limitation, setting up necessary procedures governing application for grant funding by local agencies, non-profit organizations and others under the program; and

**WHEREAS**, the County of Humboldt (“County”), by and through the Humboldt County Department of Public Works, desires to apply for, and accept, if awarded, funding made available through the California Climate Investment Fire Prevention Grant Program in order to complete the Community Wildfire Protection Plan Phase IV: Wildfire Preparedness project (“Phase IV – Wildfire Preparedness”).

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County Department of Public Works Director, or a designee thereof, is hereby authorized to submit an application and any other documents required, or deemed necessary, to secure an award of funding made available through the California Climate Investment Fire Prevention Grant Program.
2. If the County’s application for funding made available through the California Climate Investment Fire Prevention Grant Program is approved by the California Department of Forestry and Fire Protection, the Humboldt County Department of Public Works Director, or a designee thereof, is hereby authorized to conduct all negotiations, and enter into, execute and deliver any and all documents, including, without limitation, agreements, amendments and payment requests, required, or deemed necessary, to complete the Phase IV – Wildfire Preparedness project.
3. If the County’s application for funding made available through the California Climate Investment Fire Prevention Grant Program is approved by the California Department of Forestry and Fire Protection, the County hereby represents and certifies that the County will have sufficient funds to operate and maintain the Phase IV – Wildfire Preparedness project.
4. If the County’s application for funding made available through the California Climate Investment Fire Prevention Grant Program is approved by the California Department of Forestry and Fire Protection, the County hereby represents and certifies that funds under the jurisdiction of the Humboldt County Board of Supervisors will be available to begin the Phase IV – Wildfire Preparedness project.
5. If the County’s application for funding made available through the California Climate Investment Fire Prevention Grant Program is approved by the California Department of Forestry and Fire Protection, the County hereby represents and certifies that all such grant funding will be expended prior to March 15, 2025 or March 15, 2026, depending on the source of the funds awarded.
