

**FIRST AMENDMENT
PROFESSIONAL SERVICES AGREEMENT
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
NATIONAL COUNCIL ON CRIME AND DELINQUENCY
FOR FISCAL YEARS 2018-2019 THROUGH 2020-2021**

This First Amendment to the Professional Services Agreement dated June 25, 2019, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and the National Council on Crime and Delinquency, a Wisconsin corporation, hereinafter referred to as "CONTRACTOR," is entered into this 23 day of June, 2020.

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Social Services ("DHHS – Social Services"), desired to retain a qualified professional organization to implement, support and maintain a specialized software system that is designed to assist DHHS – Adult Protective Services with its intake assessment process; and

WHEREAS, on June 25, 2019, COUNTY and CONTRACTOR entered into a Professional Services Agreement regarding the implementation, support and maintenance of the Structured Decision Making software system; and

WHEREAS, the parties now desire to amend certain provisions of the Professional Services Agreement in order to extend the term thereof and modify the execution requirements set forth therein.

NOW THEREFORE, the parties mutually agree as follows:

1. Section 2 – Term of Professional Services Agreement is hereby amended to read as follows:

2. TERM:

This Agreement shall begin on June 25, 2019 and shall remain in full force and effect until June 30, 2021, unless sooner terminated as provided herein.

2. Section 40 – Counterpart Execution of the Professional Services Agreement is hereby amended to read as follows:

40. COUNTERPART EXECUTION:

This Agreement, and any amendments hereto, may be executed in one (1) or more counterparts, each of which shall be deemed to be an original and all of which, when taken together, shall be deemed to be one (1) and the same agreement. This Agreement, and any amendments hereto, may be signed by manual or electronic signatures in accordance with any and all applicable local, state and federal laws, regulations and standards, and such signatures shall constitute original signatures for all purposes. A signed copy of this Agreement, and any amendments hereto, transmitted by email or by other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Agreement and any amendments hereto.


3. Except as modified herein, the Professional Services Agreement dated June 25, 2019 shall remain in full force and effect. In the event of a conflict between the provisions of this First Amendment and the original Professional Services Agreement, the provisions of this First Amendment shall govern.
