RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING ACCEPTANCE OF FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT'S HOUSING NAVIGATORS PROGRAM

WHEREAS, on October 15, 2021, the California Department of Housing and Community Development ("HCD") issued an Allocation Acceptance Form under the Housing Navigators Program ("HNP") totaling Five Million Dollars (\$5,000,000.00) as authorized by Item 2240-103-0001 of Section 2 of the California Budget Act of 2019, as amended by California Assembly Bill 128; and

WHEREAS, the County of Humboldt ("County") has received an allocation of HNP funding in the amount of Thirty Thousand Four Hundred Ninety-Five Dollars (\$30,495.00); and

WHEREAS, on November 4, 2021, the County, by and through its Department of Health and Human Services ("DHHS"), submitted an application for HNP funding in accordance with the requirements of the Allocation Acceptance Form dated October 15, 2021; and

WHEREAS, HCD may approve HNP funding allocations subject to the terms and conditions of a State of California Standard Agreement ("State Standard Agreement"), as well as any other applicable agreements, between HCD and recipients of HNP funding.

NOW THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. If the County's application for HNP funding dated November 4, 2021 is approved by HCD, the Humboldt County DHHS Director, or a designee thereof, is hereby authorized to enter into, execute and deliver, in accordance with any and all applicable local, state and federal laws, regulations and standards, a State Standard Agreement for an amount not to exceed Thirty Thousand Four Hundred Ninety-Five Dollars (\$30,495.00), and any amendments thereto, along with any and all other documents required or deemed necessary or appropriate to accept and secure HNP funding and the County's obligations related thereto.
- 2. If the County's application for HNP funding dated November 4, 2021 is approved by HCD, the County hereby represents and certifies that all such HNP funding will be used in a manner consistent, and in compliance, with any and all applicable local, state and federal laws, regulations, requirements and standards, including, without limitation, any and all applicable laws, regulations, requirements and standards regarding HNP funding, as well as any and all applicable agreements between the County and HCD.
- 3. If the County's application for HNP funding dated November 4, 2021 is approved by HCD, the County hereby agrees to use such HNP funding for eligible activities as approved by HCD and in accordance with any and all applicable HNP requirements, and any other applicable local, state and federal laws, regulations and standards, as well as in a manner consistent, and in compliance, with the State Standard Agreement, and any other applicable agreements, between the County and HCD.
