AUTHORITY: Formed July 10, 1956, by Board Order, and reorganized by Board Order on June 3, 1964; Ordinances 682, 1660, 1665, and 2050

APPOINTING POWER: Board of Supervisors

MEMBERS: Fifteen (15) – The Supervisor of each District shall appoint three (3) members (not required to live in District). Serve at POB. The BOS *may* appoint up to five (5) associate non-voting members that serve at the pleasure of the Board.

QUALIFICATIONS: Interest in County issues regarding fishing and game hunting

TERM: Terms Expire on June 30th - Four (4) Year Staggered Terms (Dist 1, 2, 3 and Dist 4, 5 expire 3 years apart)

FUNCTION: Established to serve in an advisory capacity to the Board of Supervisors in all matters concerning fish and wildlife within the County of Humboldt.

Because of my experience working on the HASA board of directors, I realize the importance of sustaining hunting and fishing opportunities in California. This can be done by collecting data and using the knowledge to educate others. I believe that when everyone understands the issue, consensus can be achieved. My fear is that opportunities will be lost unnecessarily.

We have many success stories at HASA, like convincing anglers to use deep water release devices and to steer clear of endangered yelloweye rockfish. The result was a decline in yelloweye bycatch and avoiding an early rockfish fishing closure. We also convinced anglers to tell the truth and cooperate with data collectors. This was noticed and applauded by CDFW personnel, HSU administration and Sea Grant.

I could go on, but the bottom line is I want to work to protect our right to hunt and fish in California.
