Because of my experience working on the HASA board of directors, I realize the importance of sustaining hunting and fishing opportunities in California. This can be done by collecting data and using the knowledge to educate others. I believe that when everyone understands the issue, consensus can be achieved. My fear is that opportunities will be lost unnecessarily. We have many success stories at HASA, like convincing anglers to use deep water release devices and to steer clear of endangered yelloweye rockfish. The result was a decline in yelloweye bycatch and avoiding an early rockfish fishing closure. We also convinced anglers to tell the truth and cooperate with data collectors. This was noticed and applauded by CDFW personnel, HSU administration and Sea Grant. I could go on, but the bottom line is I want to work to protect our right to hunt and fish in California.
