Public members: Three members serve 3-year terms and three members serve 4-year terms (no appointee shall serve for more than two consecutive terms). (Regardless of appointment date, terms

expire on the original appointment dates)

FUNCTION: Adopt an adequate and complete county strategic plan for support and improvement of early

childhood development within the County, consistent with the requirements of the *California Children and Families First Act of 1998* and any state regulations or guidelines hereinafter enacted

to implement the Act.
