Good Morning.

1. I am here today to present to you a Christmas Greeting, in the form of a holiday card and an excerpt from a poem by Henry Wadsworth Longfellow- **Christmas Bells**.
(The page is copied from **The Metropolitan Museum of Art 'Twas the Night Before Christmas and Other Seasonal Favorites** published by Henry Abrams, Inc., New York 2003.)
2. Also, I apologize for personally handing you my last comment versus filing it with the clerk before presenting it to you- I was a bit flustered after hearing the comment made before mine that day.
3. It is a difficult thing to come here week after week, to beg for help in recovering my property- my-our home(s), and land security, yet it is the responsible thing to do, for various reasons; As oversight which is required, in this county, in my humble opinion, would be to hold local attorneys to account for their bad actor actions, and other persons who are/were elected or appointed officials who have abused their power.
4. When the abuse of the legal process has caused the "Civil" part of the judiciary, to be used to cause what I am alleging are criminal acts, it is makes evictions of persons affiliated with the terrifying, and terribly confusing.
5. One might wonder why, I sued persons in civil court instead of pressing for criminal investigation from the start- the simple answer, is that I and my husband were directed to do so, that is to hire private attorneys to do so, by attorney generals in two states, (whom we both voted for and supported), until we realized how inappropriate it was to pass off such a duty and expense to adjudicate criminal acts/prosecute bad actors onto the victims.

Therefore the submission today includes photos of (and a notice posted yesterday at) 367 Shaw Avenue in Ferndale, California, to add pictures to this narrative. As I need your help -to reach out to official law enforcement to help me recover our family's stolen home and other types of property-so as to uphold the rule of law.

Henry Wadsworth Longfellow, American, 1807–1882

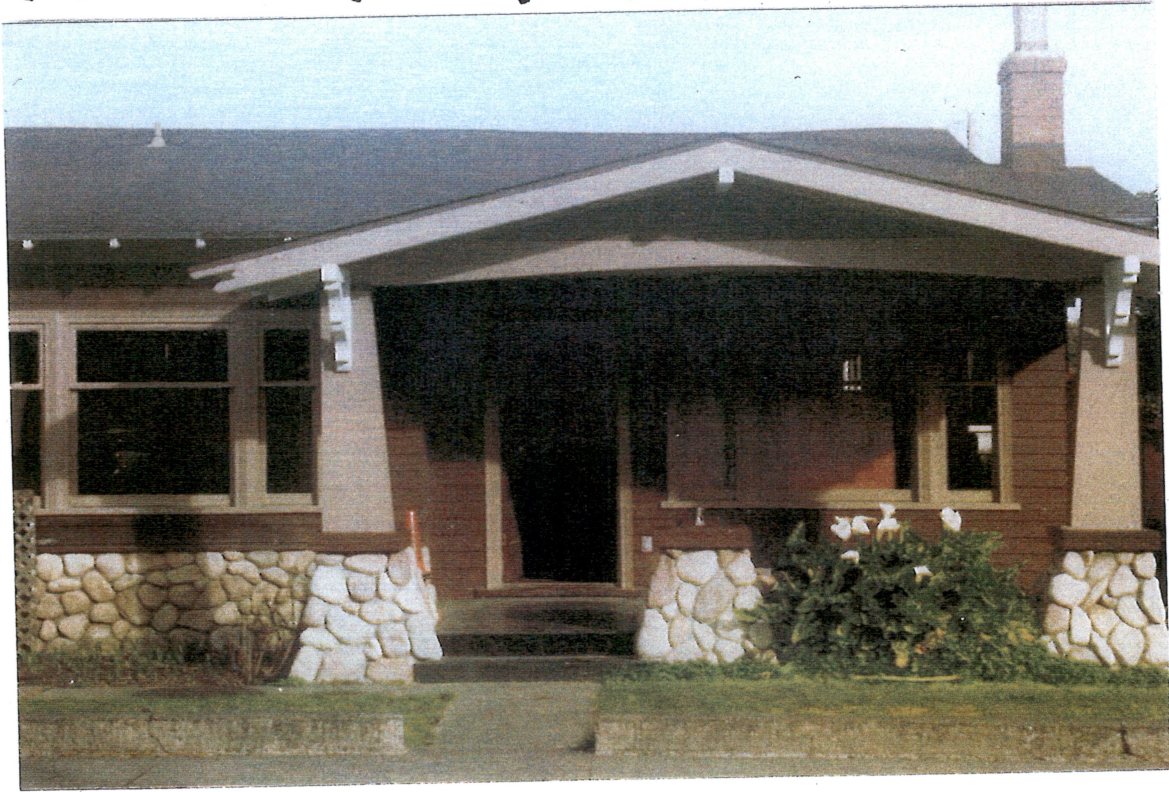
I heard the bells on Christmas Day

SENT IN GOOD FAITH

This Notice is an attempt to mitigate any and all damages related to crimes against property at 367 Shaw Avenue Ferndale, California, and discover how to file criminal complaints regarding crimes we allege were committed against our child, our selves, or any others affected by abuse of process and denial of the rule of law, where I, Dawn Alexandra Profant, and I, Peter Profant invoked inalienable rights which we asserted to Police Chief Smith in 2016 and others, in an attempt to avert damages-where bogus trespassing charges brought against me, Peter Profant for "Trespassing" at 367 Shaw Avenue Ferndale California, in October 2016. Said Identity theft caused me to be scared away from my home, along with my wife and daughter, and our vehicles were stolen from, and or unlawfully towed from our home as well, before charges against me, Peter Profant, were dropped by the District Attorney, The Honorable Maggie Fleming, where The Reason for dropping said false misdemeanor charges made by Jennifer Raymond to Ferndale Police against me, generating a ticket# 16-122, was done so :

"In the Interest of Justice."

This statement was entered into the record on November 21, 2019 by Whitney R. Timm, as the attorney and acknowledged/signed by Betty Resendez for The Honorable Maggie Fleming County of Humboldt District Attorney.

This ruling was an addition to, the rule of Law decided in the Humboldt County Superior Court and called out in several cases-orders /court acknowledgements since March 2014, (CP140122) November 2015(DR150158), and May 2016(CV150874), and again in November 2016(per the aforementioned District Attorney dismissal/ letter)

Therefore, we, The Profants, I, Peter Profant, and I, D. Alexandra Profant, assert that we, and our child, have the right to recover and inhabit said premises at 367 Shaw Avenue Ferndale California, post-haste, as a result of the rule of law, being ignored and where abuse of process by multiple attorneys, and an abuse of power while Steve Avis was official-The City of Ferndale Planner, and later as an elected official to the City of Ferndale City Council, Steve Avis, caused, I allege, numerous criminal acts, ending in and with intended confusions to ensnare the City of Ferndale Police personnel into his causes of actions against us and our daughter.

Facts:

Dawn Alexandra Profant, and Peter James Profant are co-trustors, co-trustees of The Profant Family Trust since 2000.

The Profant Family Trust, and we, as husband - wife, and individuals, and parents, are the superior claimants and true owners - protectors of 367 Shaw Avenue Ferndale CA. with the historic AP. No. 31-072-05.

We object to any and all persons using this AP Number to assert any claim, or right of adverse possession, by way of paying taxes to the County of Humboldt or the State of California where frauds persist on title and foreclosures, based on false claims, unlawful conveyances causing pretended ownership, have yet to be prosecuted.
