Trinidad Area Plan text changes to the California Coastal Commission for certification in accordance with the Coastal Act.

5. Direct the Clerk of the Board to give notice of the decision to the applicant/owner, the County Assessor's Office and any other interested party, and direct Planning and Building Department – Planning Division to file a Notice of Exemption pursuant to California Environmental Quality Act (CEQA).

#### SOURCE OF FUNDING:

The applicant is responsible for all costs associated with the processing of the project. Applicant fees are deposited into Planning and Building Department Current Planning Revenue Account 1100-277-608000.

#### DISCUSSION:

##### *Summary*

The project before the Board of Supervisors is a General Plan Amendment (GPA) /Local Coastal Plan Amendment to the Trinidad Area Plan to allow for a water line extension from the City of Trinidad domestic water system to serve CalFire's Trinidad Fire Station. Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The fire station currently uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. Cal Fire has documented evidence that this water supply is unreliable and potentially unsafe. Therefore, the fire station is looking for an alternative potable water supply.

The CalFire property is located outside of the mapped water service area of the Trinidad area plan and so requires a Local Coastal Plan Amendment to allow for extension of domestic water service from the City of Trinidad. The approach proposed is to add language to the Trinidad Area Plan that allows for a specific exception for providing the water service only to the CalFire Trinidad Station similar to what was done in the McKinleyville Area Plan to provide service to the Coast Guard Station.

The proposed extension of City of Trinidad water service to the fire station was initiated as early as 2009, with a preliminary feasibility evaluation by then-Trinidad City Engineer Winzler & Kelly, and submitted to the Humboldt County Local Agency Formation Commission (LAFCo). Results found that the fire station's estimated peak demand of 800 gallons per day is less than 1% of the City of Trinidad's available capacity and that the City has available water supply and could provide the fire station with potable water. In May 2010, Humboldt LAFCo determined that a Cortese-Knox-Hertzberg Act, Section 56133 exemption was applicable for the water service extension, given that the service in question involves a public service provider. Therefore the proposed service extension does not require further LAFCo approval. The proposed project is concurrently undergoing a review by the City of Trinidad and requires the City also amend their general plan.

The applicant has successfully petitioned your Board to accept an applicant initiated General Plan Amendment of the subject property to facilitate the domestic water extension.

## ***Required Findings***

### ***A. Required Findings for General Plan Amendments/Zone Reclassifications***

The General Plan of Humboldt County is a dynamic document that can be modified to reflect changing social, economic or environmental conditions, or changes in state law. Per Section 1452.2, *Findings Required*, of the Trinidad Area Plan and the Framework Plan, an amendment may be approved if:

1. Base information or physical conditions have changed; or
2. Community values and assumptions have changed; or
3. There is an error in the plan; or
4. To maintain established uses otherwise consistent with a comprehensive view of the plan.

### ***B. State Planning and Zoning Law(Government Code §65300 et seq.) and Sections 312-50.3 and 312-50.8 of the Humboldt County Code Zoning Regulations, Required Findings for All Amendments, may be approved only if the following applicable findings are made:***

1. The amendment is in the public interest;
2. The amendment is consistent with the General Plan;
3. The amendment does not reduce the residential density for any parcel below that utilized by the Department of Housing and Community Development in determining compliance with housing element law.
4. Required Findings for Consistency with the Coastal Act – Plan Amendments & Zone Reclassifications

Title 14, §13551 of the Coastal Commission's Administrative Regulations, and Public Resources Code, §30200 requires proposed amendments to conform to the policies contained in Chapter 3 of the Coastal Act, which sets forth policies regarding the following issues:

Finding: Access (including provisions for access with new development projects, public facilities, lower cost visitor facilities, and public access).

Finding: Recreation (including protection of water-oriented activities, ocean-front land protection for recreational uses, aqua- cultural uses, and priority of development purposes).

Finding: Marine Resources (including protecting biological productivity, prevent hazardous waste spills, diking, filling and dredging, fishing, revetments and breakwaters, and water supply and flood control).

Finding: Land Resources (including protection of environmentally sensitive habitats, agricultural lands, timberlands, and archaeological or paleontological resources)

Finding: Development (including placing new development within or close to existing developed areas, protection of scenic resources, maintenance of public access by encouraging public transit, providing for recreational opportunities within new development, protection of public safety, expansion of public works facilities and priority of coastal dependent developments)

Finally, the California Environmental Quality Act (CEQA) states that one of the following findings must be made prior to approval of any development which is subject to the regulations of CEQA:

- The project either is categorically or statutorily exempt; or
- There is no substantial evidence that the project will have a significant effect on the environment or any potential impacts have been mitigated to a level of insignificance and a negative declaration has been prepared pursuant to Section 15070 of the CEQA Guidelines; or
- An environmental impact report (EIR) has been prepared and all significant environmental effects have been eliminated or mitigated to a level of insignificance, or the required findings in Section 15091 of the CEQA Guidelines are made.

### ***Staff Recommendation***

Planning staff supports the project because the required findings can be made. The General Plan Amendment is in the public interest; the amendment reflects the fact that the changes are necessary to maintain established uses otherwise consistent with a comprehensive view of the plan. The amendments, as supported by planning staff, are consistent with Plan policies and with the development capabilities of the property. The finding can also be made that the amendment is in conformance with the 1984 Framework General Plan, The Trinidad Area Local Coastal Plan, and the General Plan Housing Element.

Based on the on-site inspection, a review of Current Planning Division reference sources and comments from all involved referral agencies, Current Planning Staff believes that the applicant has submitted evidence in support of making all of the required findings for approving the project. The Humboldt County Planning Commission concurred, recommending approval of the project.

### ***Evidence to support the findings***

#### **(Findings for Undertaking Plan Amendments)**

##### **A. The amendment is necessary to maintain established uses otherwise consistent with a comprehensive view of the plan.**

Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The fire station currently uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. Cal Fire has documented evidence that this water supply is unreliable and potentially unsafe. Therefore, the fire station is looking for an alternative potable water supply.

The proposed extension of City of Trinidad water service to the fire station was initiated as early as 2009, with a preliminary feasibility evaluation by then-Trinidad City Engineer Winzler & Kelly, and submitted to the Humboldt County Local Agency Formation Commission (LAFCo). Results found that the fire station's estimated peak demand of 800 gallons per day is less than 1% of the City of Trinidad's available capacity and that the City has available water supply and could provide the fire station with potable water. In May 2010, Humboldt LAFCo determined that a Cortese-Knox-Hertzberg Act, Section 56133 exemption was applicable for the water service extension, given that the service in question involves a public service provider. Therefore the proposed service extension does not require further LAFCo approval.

The extension of water service is inconsistent with the current Local Coastal Programs (LCP) of both the City of Trinidad and Humboldt County. The project parcel is outside of (but directly adjacent to) the City of Trinidad's City service area. Therefore, amendments to the Trinidad General Plan and the County's Trinidad Area Plan first need to be locally adopted and then certified by the Coastal Commission before Coastal Development Permits for the proposed project could be found to be consistent with the LCPs. The applicant is concurrently applying to the City of Trinidad for their necessary coastal plan amendment.

The proposed water line extension will be designed and/or conditioned to serve only the fire station. Cal Fire's proposal is to request amendment to the LCP to allow the extension of water service to just this project, potentially through a targeted exception (LCP text amendment) for this project, without extending the mapped service area boundary. The application suggests that the right conditions incorporated into the LCP amendment to prevent growth inducement concerns could limit the scope of the necessary special studies and lessen potential controversy because the fire station is an essential public service facility and the proposed water line will serve only the fire station.

Staff believes that it can be demonstrated that the proposed change will maintain the established uses on the property otherwise consistent with a comprehensive view of the plan. Therefore, staff believes that the findings can be made on the basis of the submitted evidence.

**(Findings for Consideration of Amendments)**

**B.1 The project is in the public interest:** The site has been developed with the CalFire Trinidad Fire Station for many years. Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The change to City of Trinidad domestic water supply will allow for this continued use.

**B.2. The project is consistent with the General Plan:** The following table identifies the evidence which supports finding that the proposed project is in conformance with all applicable policies and standards in Chapter 2-4 of the Framework Plan (FRWK) and Trinidad Area Plan (TAP).

The City of Trinidad has determined that it has the capacity to provide for this domestic water need while maintaining the necessary reserves for development within the community. To ensure that the extension is limited to the purpose identified in the amendment, Section 3.23B.1 of the TAP will be amended to provide that the service extension is limited <i>“to the CalFire Trinidad Fire Station located at 923 Patricks Point Drive” and “sized so as not to exceed provision of the minimum amount of water needed to serve the fire station for domestic water use only.”</i> As restricted, the proposed amendment is consistent with the Development policies of the Coastal Act.</p>	

**Environmental Impact:** The following table identifies the evidence which supports finding that the proposed location of the use and conditions under which it may be operated or maintained will not be detrimental to the public health, safety or welfare, or materially injurious to properties or improvements in the vicinity, and will not adversely impact the environment.

FINANCIAL IMPACT:

There will be no impact on the General Fund. The applicant is responsible for paying all actual costs involved in the processing of the application. This payment is typical for all individually-initiated plan amendment and zone reclassification applications.

BOARD'S STRATEGIC FRAMEWORK:

The Local Coastal Program Amendment supports the Board's Strategic Framework through its core role of providing for and maintaining critical infrastructure.

OTHER AGENCY INVOLVEMENT:

Current Planning Staff referred the proposed General Plan Amendment to numerous agencies for comments and recommendations. All responding agencies have either recommended approval or conditional approval of the project.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board may choose not to approve the project. Staff does not recommend this alternative. Staff believes that satisfactory evidence has been provided in the project record to support making the required findings.

**WHEREAS**, the Planning Division, the lead agency, found the project exempt from environmental review pursuant to Section 15265 the California Environmental Quality Act (CEQA); and

**WHEREAS**, Exhibit A includes evidence in support of making all of the required findings for approving the proposed General Plan Amendment/Local Coastal Program Amendment application for Case No.: GPA-16-004; and

**WHEREAS**, the Planning Commission has reviewed and considered said reports and other written and spoken evidence and testimony presented to the Commission during a public hearing on August 24, 2017, and





Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The fire station currently uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. Cal Fire has documented evidence that this water supply is unreliable and potentially unsafe. Therefore, the fire station is looking for an alternative potable water supply.

The proposed extension of City of Trinidad water service to the fire station was initiated as early as 2009, with a preliminary feasibility evaluation by then-Trinidad City Engineer Winzler & Kelly, and submitted to the Humboldt County Local Agency Formation Commission (LAFCo). Results found that the fire station's estimated peak demand of 800 gallons per day is less than 1% of the City of Trinidad's available capacity and that the City has available water supply and could provide the fire station with potable water. In May 2010, Humboldt LAFCo determined that a Cortese-Knox-Hertzberg Act, Section 56133 exemption was applicable for the water service extension, given that the service in question involves a public service provider. Therefore the proposed service extension does not require further LAFCo approval.

California Coastal Commission staff indicated in a summary email on July 11, 2014, that any such extension of water service would be inconsistent with the current Local Coastal Programs (LCP) of both the City of Trinidad and Humboldt County. The project parcel is outside of (but directly adjacent to) the City of Trinidad's City service area. Therefore, amendments to the Trinidad General Plan and the County's Trinidad Area Plan would first need to be locally

adopted and then certified by the Coastal Commission before Coastal Development Permits for the proposed project could be found to be consistent with the LCPs. The applicant is concurrently applying to the City of Trinidad for their necessary coastal plan amendment.

The proposed water line extension would be designed and/or conditioned to serve only the fire station. Cal Fire requests amending the LCPs to allow the extension of water service to just this project, potentially through a targeted exception (LCP text amendment) for this project without extending the service area boundary. The application suggests that the right conditions incorporated into the LCP amendment to prevent growth inducement concerns could limit the scope of the necessary special studies and lessen potential controversy because the fire station is an essential public service facility and the proposed water line will serve only the fire station.

**Finding 3. The project is in the public interest.**

**Evidence to Support the Finding:**

The site has been developed with the CalFire Trinidad Fire Station for many years. Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The change to City of Trinidad domestic water supply will allow for this continued use.

**Finding 4. The amendment does not reduce the residential density for any parcel below that utilized by the Department of Housing and Community Development in determining compliance with housing element law.**

**Evidence to Support the Finding:**

The proposed project is sited on lands historically utilized for public facility (fire station) uses. The parcel was not utilized by the Department of Housing and Community Development in determining compliance with housing element law.

#### *B. DEVELOPMENT POLICIES*

##### *1. Extension of Services*

*It is the intent of this chapter that extensive rural public service systems, such as water and sewer, not be developed. This is exclusive of such public systems such as roads, electric, gas, telephone, and fire protection systems appropriate to planned levels of development. No permit shall be issued by any agency of the County to a special district or private utility or mutual system proposing to provide such services outside an Urban Limit Line or the area identified as the Westhaven Village area; except that provision of water service shall **only** be permitted, **(i)** within the service area, if sized so as not to exceed the maximum number of residential sites and other planned uses which can be developed under the adopted plan, **and (ii) to the CalFire Trinidad Fire Station located at 923 Patricks Point Drive, if sized so as not to exceed provision of the minimum amount of water needed to serve the fire station for domestic water use only.***

*In addition, extension of water service outside of the Urban Limit Line as defined in the plan **to the service area or to the CalFire Trinidad Fire Station** shall **only** be permitted provided that:*

- a. service along the extension will not remove capacity necessary to serve future development on undeveloped lots within the existing serviced areas, whether within the Urban Limit Line or not, to the uses permitted in the plan;*
- b. developments to be serviced are compatible with the plan;*
- c. the extension of water service will be paid for only by the users of that service;*
- d. the existing system is in no way degraded and that fire protection services are in no way impaired; and*
- e. the proposed service is found to be in conformance with the resource protection policies of this plan.*



**LOCATION MAP**





## ATTACHMENT 1

### CONDITIONS OF APPROVAL

Approval of the General Plan Amendment/LCP Amendment is conditioned on the following terms and requirements that must be satisfied before the project can be scheduled for action by the Board of Supervisors.

1. The applicant shall submit a check payable to Humboldt County Recorder in the amount of \$50.00. *Note: If a required filing fee is not paid for the project, the project will not be operative, vested or final and any local permits issued for the project will be invalid (Section 711.4(c)(3) of the State Fish and Game Code).*
2. The applicant is required to pay for permit processing on a time and material basis as set forth in the schedule of fees and charges as adopted by ordinance of the Humboldt County Board of Supervisors. The Department will provide a bill to the applicant upon file close out after the Planning Commission decision. Any and all outstanding Planning fees to cover the processing of the application to decision by the Hearing Officer shall be paid to the Humboldt County Planning Division, 3015 H Street, Eureka.

#### Informational Notes:

1. The project site is not located within an area where known cultural resources have been located. However, as there exists the possibility that undiscovered cultural resources may be encountered during construction activities, the following mitigation measures are required under state and federal law:

If archaeological resources are encountered during construction activities, the contractor on site shall cease all work in the immediate area and within a 50 foot buffer of the discovery location. A qualified archaeologist as well as the appropriate Tribal Historic Preservation Officer(s) are to be contacted to evaluate the discovery and, in consultation with the applicant and lead agency, develop a treatment plan in any instance where significant impacts cannot be avoided.

The Native American Heritage Commission (NAHC) can provide information regarding the appropriate Tribal point(s) of contact for a specific area; the NAHC can be reached at 916-653-4082. Prehistoric materials may include obsidian or chert flakes, tools, locally darkened midden soils, groundstone artifacts, shellfish or faunal remains, and human burials. If human remains are found, California Health and Safety Code 7050.5 requires that the County Coroner be contacted immediately at 707-445-7242. If the Coroner determines the remains to be Native American, the NAHC will then be contacted by the Coroner to determine appropriate treatment of the remains pursuant to PRC 5097.98. Violators shall be prosecuted in accordance with PRC Section 5097.99.

The applicant and successors are ultimately responsible for ensuring compliance with this condition.

2. Upon certification of the proposed amendment to the Local Coastal Program (LCP), the Department may receive and process a coastal development permit (CDP) for the proposed water line extension project. Referral comments submitted for this LCP amendment would apply to the CDP application, including:

- a. Prior to installation of the water main line, the applicant must apply for and obtain an Encroachment Permit for all work in the County maintained right-of-way of Patrick's Point Drive (3N010). Any future connections to the water line will require a separate Encroachment Permit.
- b. The water meter shall be installed outside the County right-of-way on the subject parcel, APN 515-241-011.
- c. The current stream diversion infrastructure shall be decommissioned to the extent feasible if it is no longer to be used, and riparian vegetation shall be planted onsite to mitigate for any areas of disturbance.
- d. The Trinidad Rancheria suggests that a Cultural Monitor be present during project construction.

## ATTACHMENT 2

### Staff Analysis of the Evidence Supporting the Required Findings

#### **A. Required Findings for General Plan Amendments/Zone Reclassifications**

The General Plan of Humboldt County is a dynamic document that can be modified to reflect changing social, economic or environmental conditions, or changes in state law. These changes include changing property from one plan designation or zone to another. Per Section 1452.2, *Findings Required*, of the Fortuna Area Community Plan and the Framework Plan, an amendment may be approved if:

1. Base information or physical conditions have changed; or
2. Community values and assumptions have changed; or
3. There is an error in the plan; or
4. To maintain established uses otherwise consistent with a comprehensive view of the plan.

#### **B. State Planning and Zoning Law (Government Code §65300 et seq.) and Sections 312-50.3 and 312-50.8 of the Humboldt County Code Zoning Regulations, Required Findings for All Amendments, may be approved only if the following applicable findings are made:**

1. The amendment is in the public interest;
2. The amendment is consistent with the General Plan;
3. The amendment does not reduce the residential density for any parcel below that utilized by the Department of Housing and Community Development in determining compliance with housing element law.
4. Required Findings for Consistency with the Coastal Act – Plan Amendments & Zone Reclassifications

Title 14, §13551 of the Coastal Commission's Administrative Regulations, and Public Resources Code, §30200 requires proposed amendments to conform to the policies contained in Chapter 3 of the Coastal Act, which sets forth policies regarding the following issues:

Finding: Access (including provisions for access with new development projects, public facilities, lower cost visitor facilities, and public access).

Finding: Recreation (including protection of water-oriented activities, ocean-front land protection for recreational uses, aqua-cultural uses, and priority of development purposes).

Finding: Marine Resources (including protecting biological productivity, prevent hazardous waste spills, diking, filling and dredging, fishing, revetments and breakwaters, and water supply and flood control).

Finding: Land Resources (including protection of environmentally sensitive habitats, agricultural lands, timberlands, and archaeological or paleontological resources)

Finding: Development (including placing new development within or close to existing developed areas, protection of scenic resources, maintenance of public access by encouraging public transit, providing for recreational opportunities within new development, protection of public safety, expansion of public works facilities and priority of coastal dependent developments)

Finally, the California Environmental Quality Act (CEQA) states that one of the following findings must be made prior to approval of any development which is subject to the regulations of CEQA:

- The project either is categorically or statutorily exempt; or
- There is no substantial evidence that the project will have a significant effect on the environment or any potential impacts have been mitigated to a level of insignificance and a negative declaration has been prepared pursuant to Section 15070 of the CEQA Guidelines; or
- An environmental impact report (EIR) has been prepared and all significant environmental effects have been eliminated or mitigated to a level of insignificance, or the required findings in Section 15091 of the CEQA Guidelines are made.

## **Evidence to support the findings**

### **(Findings for Undertaking Plan Amendments)**

#### **A. The amendment is necessary to maintain established uses otherwise consistent with a comprehensive view of the plan.**

Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The fire station currently uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. Cal Fire has documented evidence that this water supply is unreliable and potentially unsafe. Therefore, the fire station is looking for an alternative potable water supply.

The proposed extension of City of Trinidad water service to the fire station was initiated as early as 2009, with a preliminary feasibility evaluation by then-Trinidad City Engineer Winzler & Kelly, and submitted to the Humboldt County Local Agency Formation Commission (LAFCo). Results found that the fire station's estimated peak demand of 800 gallons per day is less than 1% of the City of Trinidad's available capacity and that the City has available water supply and could provide the fire station with potable water. In May 2010, Humboldt LAFCo determined that a Cortese-Knox-Hertzberg Act, Section 56133 exemption was applicable for the water service extension, given that the service in question involves a public service provider. Therefore the proposed service extension does not require further LAFCo approval.

California Coastal Commission staff indicated in a summary email on July 11, 2014, that any such extension of water service would be inconsistent with the current Local Coastal Programs (LCP) of both the City of Trinidad and Humboldt County. The project parcel is outside of (but directly adjacent to) the City of Trinidad's City service area. Therefore, amendments to the Trinidad General Plan and the County's Trinidad Area Plan would first need to be locally adopted and then certified by the Coastal Commission before Coastal Development Permits for the proposed project could be found to be consistent with the LCPs. The applicant is concurrently applying to the City of Trinidad for their necessary coastal plan amendment.

The proposed water line extension would be designed and/or conditioned to serve only the fire station. Cal Fire requests amending the LCPs to allow the extension of water service to just this project, potentially through a targeted exception (LCP text amendment) for this project without extending the service area boundary. The application suggests that the right conditions incorporated into the LCP amendment to prevent growth inducement concerns could limit the scope of the necessary special studies and lessen potential controversy because the fire station is an essential public service facility and the proposed water line will serve only the fire station.

Staff believes that it can be demonstrated that the proposed change will maintain the established uses on the property otherwise consistent with a comprehensive view of the plan. Therefore, staff believes that the findings can be made on the basis of the submitted evidence.

### **(Findings for Consideration of Amendments)**

**B.1 The project is in the public interest:** The site has been developed with the CalFire Trinidad Fire Station for many years. Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time

the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The change to City of Trinidad domestic water supply will allow for this continued use.

**B.2. The project is consistent with the General Plan:** The following table identifies the evidence which supports finding that the proposed project is in conformance with all applicable policies and standards in Chapter 2-4 of the Framework Plan (FRWK) and Trinidad Area Plan (TAP) .

B. DEVELOPMENT POLICIES

1. Extension of Services

It is the intent of this chapter that extensive rural public service systems, such as water and sewer, not be developed. This is exclusive of such public systems such as roads, electric, gas, telephone, and fire protection systems appropriate to planned levels of development. No permit shall be issued by any agency of the County to a special district or private utility or mutual system proposing to provide such services outside an Urban Limit Line or the area identified as the Westhaven Village area; except that provision of water service shall only be permitted, (i) within the service area, if sized so as not to exceed the maximum number of residential sites and other planned uses which can be developed under the adopted plan, and (ii) to the CalFire Trinidad Fire Station located at 923 Patricks Point Drive, if sized so as not to exceed provision of the minimum amount of water needed to serve the fire station for domestic water use only.

In addition, extension of water service outside of the Urban Limit Line as defined in the plan to the service area or to the CalFire Trinidad Fire Station shall only be permitted provided that:

- a. service along the extension will not remove capacity necessary to serve future development on undeveloped lots within the existing serviced areas, whether within the Urban Limit Line or not, to the uses permitted in the plan;
- b. developments to be serviced are compatible with the plan;
- c. the extension of water service will be paid for only by the users of that service;
- d. the existing system is in no way degraded and that fire protection services are in no way impaired; and
- e. the proposed service is found to be in conformance with the resource protection policies of this plan.

# Proposed Extension of City of Trinidad Water Service to CAL FIRE Trinidad Station

## Project Description

### Introduction

On behalf of CAL FIRE, SHN Engineers & Geologists has prepared this project description for the CAL FIRE Humboldt-Del Norte Unit Trinidad Fire Station, located at 923 Patrick's Point Drive (Assessor's parcel number 515-241-011), in the community of Trinidad, in Humboldt County, California (Figure 1). The fire station is located approximately 1 mile beyond (north of) the City of Trinidad sphere of influence (SOI). It is within County Service Area Number Four (CSA4), which provides year-round fire protection service from McKinleyville to Orick. The proposed project is located within the California Coastal Zone and requires coastal development permits (CDPs) from both the City of Trinidad and the County of Humboldt.

SHN has prepared this project description to provide the California Coastal Commission (CCC), Humboldt County Planning and Building Department, and the City of Trinidad's Department of Planning and Building Services with information regarding the proposed extension of the City of Trinidad's water service to the CAL FIRE Trinidad Fire Station.

### Background

CAL FIRE staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad and is staffed, CAL FIRE's engine is usually on-scene faster than the Volunteer response. CAL FIRE is and has been providing this service at no cost to the City, clearly demonstrating a public service and public good to the City, as well as surrounding areas.

Existing site features at the CAL FIRE Trinidad Station (fire station) are shown on Figures 2a and 2b. Currently, the fire station uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. CAL FIRE has documented evidence that this water supply is unreliable and potentially unsafe and therefore the fire station is looking for an alternative potable water supply.

The proposed extension of City of Trinidad water service to the fire station was initiated as early as 2009, with a preliminary feasibility evaluation, conducted by Trinidad City Engineer Winzler & Kelly, and submitted to Humboldt Local Agency Formation Commission (LAFCo). The evaluation was to determine the potential water demand from the fire station, the available water supply from the City of Trinidad, and the infrastructure necessary to make the connection. Results found that the fire station's estimated peak demand of 800 gallons per day is less than 1% of the City of Trinidad's available capacity and that the City has available water supply and could provide the fire station with potable water.

In May 2010, Humboldt LAFCo determined that a Cortese-Knox-Hertzberg Act, Section 56133 exemption was applicable for the water service extension, given that the service in question involves a public service provider. Consequently, on May 19, 2010, Humboldt LAFCo approved CAL FIRE's application, and passed and adopted Resolution 10-07 determining that a LAFCo exemption applies for the water service extension from the City of Trinidad to serve the fire station; therefore the proposed service extension does not require LAFCo approval.

However, in response to a CAL FIRE request, the CCC indicated in a summary email on July 11, 2014, that any such extension of water service would be inconsistent with the current Local Coastal Programs (LCP) of both the City of Trinidad and Humboldt County. The project parcel is outside of (directly adjacent to, on the north side of) the City of Trinidad's City service area/City service limit line (Figures 3 and 4). Therefore, amendments to the Trinidad General Plan and the Trinidad Area Plan would first need to be locally adopted and then certified by the CCC before CDPs for the proposed project could be found to be LCP-consistent and approved.

## Proposed Project

The proposed water line will serve only the fire station. Once potable water has been extended to the site from City of Trinidad, the station will continue to use the existing surface water supply for equipment cleaning, irrigation, and fire suppression, thus limiting the potable water demand to indoor water use. Engineering design is required for the installation of a 1.5-inch water line along Patrick's Point Drive (PPD; approximately 5,400 linear feet), and the connection to the existing 10,000-gallon tank at the facility (approximately 600 linear feet). It is anticipated that the water line along PPD will be installed using horizontal directional drilling (HDD) to a meter at the station, and the connection from the meter at PPD to the existing facility water tank will be installed using open trenching. The project also includes the installation of a new 20,000-gallon concrete water tank for utility water/fire suppression storage; a geotechnical investigation will be needed for design purposes. The existing water supply system will be retrofitted to supply partially-treated utility water. The existing storage building will be demolished and a new building will be constructed to house the water treatment systems and pump components. New piping from the existing 10,000-gallon potable water tank to the buildings will be installed.

Design requirements for upgrading the water system at the site are expected to include design plan and profile drawings for the installation of the potable and utility water lines, including connections to the new and existing water storage tanks, the new water treatment system, and existing buildings and hose bibs. Plans will include a chlorination dosing system for the new potable water system and an evaluation of system hydraulics for the selection of adequate booster pumps.

Plans will include subsurface characterization and geotechnical investigations to provide geotechnical analysis and conclusions to aid in the design of the waterline alignment and present recommendations and design criteria. SHN will prepare initial permitting documents for review by the City of Trinidad and the County of Humboldt, including grading and encroachment permits.

CAL FIRE would like to explore the possibility of amending the LCPs to allow the extension of water service to just this project, potentially a targeted exception for this project without extending the service area boundary. With the right conditions incorporated into the LCP amendment to

prevent growth inducement concerns, this could limit the scope of necessary special studies. Potential controversy might also be lessened because the fire station is an essential public service facility and the proposed water line will serve only the fire station.



1. The Plan amendment is in the public interest because the site has been developed with the CalFire Trinidad Fire Station for many years. Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The change to City of Trinidad domestic water supply will allow for this continued use.
2. The Plan amendment is necessary because base information and physical conditions have changed; i.e.  
Cal Fire staffs the fire station year-round and responds to the City of Trinidad for all medical, traffic accident, structural and wildland fire dispatches at the same time the Trinidad Volunteer Fire Department is dispatched. Because the fire station is very close to the City of Trinidad, Cal Fire's engine is usually on-scene faster than the Volunteer response. The fire station currently uses nearby surface water from Martin Creek to supply water for drinking, equipment cleaning, irrigation, and fire suppression. Cal Fire has documented evidence that this water supply is unreliable and potentially unsafe. Therefore, the fire station is looking for an alternative potable water supply.

**NOW, THEREFORE BE IT RESOLVED**, that this Board of Supervisors hereby finds that the proposed Local Coastal Plan Amendment have been prepared in accordance with the California Public Resources Code, Division 20, California Coastal Act of 1976, as amended, and is consistent with the provisions of said Act.

**BE IT FURTHER RESOLVED** that this Board of Supervisors hereby intends to carry out the Local Coastal Program in a manner fully consistent with the California Coastal Act.


