



HUMBOLDT COUNTY SHERIFF'S OFFICE ELECTRONIC MONITORING PROGRAM RULES AND REQUIREMENTS

REQUIREMENTS:

1. There is no Administration Fee associated with the program.
2. Must be serving a county jail sentence or be scheduled to serve a county jail sentence to be eligible for the program.
3. Poor inmate work or behavior history may result in being ineligible for the program.
4. Must not, by the nature of the offense, pose a threat to the community or previous victims.
5. Must not have a propensity toward violence or disrespectful behavior as determined by criminal records or jail classification records.
6. Must display a willingness to comply with the rules and regulations of this program.
7. Must have an address of residence where they will be residing for the purposes of a nightly curfew that possess the ability to charge the monitor daily.

RULES:

1. Participants must adhere to all rules established within this agreement to include mandated curfews, charging of equipment, work assignments, and any other requirements established herein.
2. The participant agrees to the use of electronic monitoring, which may include Global Positioning System devices or other supervising devices for the purpose of helping to verify his or her compliance with the rules and regulations of the home detention program. The devices shall not be used to eavesdrop or record any conversation, except a conversation between the participant and the person supervising the participant which is to be used solely for purposes of voice identification.
3. The participant agrees that the Sheriff or their designee in charge of the Humboldt County Correctional Facility may, without further order of the court, immediately retake the person into custody to serve the balance of his or her sentence if the electronic monitoring or supervising devices are unable for any reason to properly perform their function at the designated place of home detention, if the person fails to remain within the place of home detention as stipulated in the agreement, if the person willfully fails to pay fees to the provider of electronic home detention services, as stipulated in the agreement, subsequent to the written notification of the participant that the payment has not been received and that return to custody may result, or if the person for any other reason no longer meets the established criteria under this section. At this time there is no fee for the program. You will be notified in writing and asked to sign a new Rules and Requirements form if a fee is imposed. A copy of the agreement shall be delivered to the participant and a copy retained by the correctional administrator.
4. Participants are subject to search and seizure while working on Electronic Monitoring at any time. Persons found in possession of contraband will be subject to disciplinary action and/or criminal charges. Contraband includes, but is not limited to, weapons, alcoholic beverages, and non-prescription drugs.
5. The participant shall admit any person or agent designated by the Sheriff or their designee

into his or her residence at any time for purposes of verifying the participant's compliance with the conditions of his or her detention.

6. Any violation of the rules of Electronic Monitoring may result in immediate termination from the program. Any participant who is terminated from Electronic Monitoring will serve the remainder of his/her sentence in jail but will receive credits for all days they successfully served their time on Electronic Monitoring.
7. All participants must comply with all Federal, State and Local laws.
8. At any time, the Sheriff or designee reserves the right to discharge anyone from the Electronic Monitoring program and order them to return to the jail to serve their sentence.
9. All participants will be given a mandated curfew time when they will be required to be at their residence. The participant shall remain within the interior premises of his or her residence during the hours designated by the correctional administrator. Violation of curfew may result in termination from the program.
10. All participants will be expected to maintain a sufficient charge of their equipment, and it is the responsibility of the participant to notify staff of any damaged/faulty equipment.
11. Any intentional damage to any provided equipment may result in termination from the program and the participant will be required to pay the cost of the equipment replacement at the cost established by the vendor.
