Resolution No. _____ for exception to the 180-day wait period Government Code Sections 7522.56 And 21224

WHEREAS, in compliance with Government Code section 7522.56 the Humboldt County Board of Supervisors must provide California Public Employees Retirement System (CalPERS) this certification resolution when hiring a retiree before 180 days has passed since her retirement; and

WHEREAS, Brenda Reynolds retires from the Humboldt County Sheriff's Office in the position as Senior Legal Office Assistant, effective June 12, 2021; and

WHEREAS, Section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is December 9, 2021, without this certification resolution; and

WHEREAS, Section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors, the Humboldt County Sheriff's Office and Brenda Reynolds certify that Brenda Reynolds has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors hereby appoints Brenda Reynolds as an extra help retired annuitant to perform the duties of the Senior Legal Office Assistant for the Sheriff's Office under Government Code section 21224, effective June 13, 2021; and

WHEREAS, the entire employment agreement, contract or appointment document between Brenda Reynolds and the Sheriff's Office has been reviewed by this body and is included herein; and

WHEREAS, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal an hourly rate; and

WHEREAS, the maximum base monthly salary for this position is \$3,903.47 and the hourly equivalent is \$22.52, and the minimum base monthly salary for this position is \$3,042.00 and the hourly equivalent is \$17.55; and

WHEREAS, the hourly rate paid to Brenda Reynolds will be \$22.52; and

WHEREAS, Brenda Reynolds has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors

hereby certifies the nature of the appointment of Brenda Reynolds as described herein and detailed in the attached agenda item titled "Temporary Employment of Retired Annuitant as Senior Legal Office Assistant in the Sheriff's Office", is necessary to fill the critically needed position of Senior Legal Office Assistant for the Sheriff's Office by June 13, 2021 because Brenda Reynolds has unique knowledge and skills related to the Correctional Facilities' administrative duties and will be able to train new staff.
