Subject: Consider Making Appointment to Fill Vacant Seats on the Shelter Cove Resort Improvement District #1 Board of Directors.

RECOMMENDATION(S): That the Board of Supervisors consider appointing David Summer to fill the vacant seat on the Shelter Cove Resort Improvement District #1 Board of Directors with a term expiring December 31, 2015.

DISCUSSION: The Shelter Cove Resort Improvement District #1 (SCRID) has an open seat on their Board of Directors due to the resignation of Dennis Harper. Pursuant to Public Resources Code Section 13036 which guides Resort Improvement District Law, the SCRID is requesting the Board of Supervisors make an appointment to fill the vacancy expiring on December 15, 2017. Two applications were received (Fred Bauer and David Summer). SCRID met on January 14, 2015 and reviewed the applications. They are recommending that David Summer be appointed to fill the vacancy, with the term expiring December 31, 2015.


