DISCUSSION:

There is a current call for projects to be funded under the Active Transportation Program (ATP) managed by the California Department of Transportation (CalTrans). The ATP is a competitive program to fund non-motorized transportation facilities within the State of California.

The purpose of ATP is to encourage increased use of active modes of transportation by achieving the following goals:

- Increase the proportion of trips accomplished by biking and walking,
- Increase safety and mobility for non-motorized users,

- Advance the active transportation efforts of regional agencies to achieve greenhouse gas (GHG) reduction goals,
- Enhance public health,
- Ensure that disadvantaged communities fully share in the benefits of the program, and
- Provide a broad spectrum of projects to benefit many types of active transportation users.

The Public Works Department has four projects that it is planning to submit for funding; two of which are county only projects, one is in partnership with CalTrans, and one is in partnership with the Humboldt Bay Harbor, Recreation and Conservation District and Danco.

The county projects include a proposal to replace the Hammond Trail Bridge and a proposal to add pedestrian improvements to McKinleyville Avenue near McKinleyville High School.

The project in partnership with CalTrans is to construct a Class 1 Trail in the CalTrans Right-of-Way along Highway 255 in Manila.

The project in partnership with the Humboldt Bay Harbor, Recreation and Conservation District and Danco is to enhance the trails required to be constructed by Danco in the Samoa area to provide improvements beyond the minimum trail requirements required of this project by the Coastal Commission to improve non-motorized travel and coastal access.

Re: Support for the County of Humboldt's Hammond Bridge Replacement Project

Dear Application Review Committee:

On behalf of the Humboldt County Board of Supervisors, I am writing to extend support for the County of Humboldt's Hammond Bridge Replacement Project.

The Hammond Trail is the most used portion of the California Coastal Trail in Humboldt County. It is a successful rail-to-trail project, extending approximately 5.5 miles from the Clam Beach County Park to the Arcata Bottoms. The Hammond Bridge has long been a part of McKinleyville's history. The original bridge on this site was a wooden covered bridge that was built in 1905 as part of the Humboldt Northern Railway. The covered bridge remained in use until 1942, yet the bridge continued to be used as a railroad bridge until 1961.

The Hammond Bridge Replacement Project will afford a safe and sound link for trail users. The replacement is necessary to maintain the current trail system. It will safeguard the only non-motorized connection between the population centers of Arcata and McKinleyville separate from highway and on/off-ramp traffic while providing a scenic view of the Mad River.
