RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS, AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS, ON BEHALF OF THE NORTH COAST RESOURCE PARTNERSHIP, TO ACCEPT AND ADMINISTER FUNDING FROM THE FOREST HEALTH GRANT PROGRAM AS PROVIDED THROUGH THE CALIFORNIA CLIMATE INVESTMENTS.

WHEREAS, the Governor of the State of California in cooperation with the California State Legislature has enacted State of California Greenhouse Gas Reduction Funding which provides funds to the State of California and its political subdivisions for Forest Health programs; and


WHEREAS, the State Department of Forestry and Fire Protection has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies and non-profit organizations under the program, and

WHEREAS, the County of Humboldt ("County"), by and through the Humboldt County Department of Public Works, and on behalf of the North Coast Resources Partnership, was invited to implement a Landscape Grant Pilot and will enter into an agreement with the State of California to carry out associated Forest Health projects;

NOW, THEREFORE, BE IT RESOLVED THAT THE HUMBOLDT COUNTY BOARD OF SUPERVISORS:

1. Certifies that said applicant has or will have sufficient funds to operate and maintain the project; and,
2. Certifies that funds under the jurisdiction of Humboldt County Board of Supervisors are available to begin the project.
3. Certifies that said applicant will expend grant funds prior to **March 30, 2026**.
4. Appoints Humboldt County Department of Public Works Director, or a designee, as agent of the Humboldt County Board of Supervisors, to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned project.
