DISCUSSION:

Welfare and Institutions Code Section 5404 authorizes counties to designate facilities as 72-hour evaluation and treatment facilities. On July 24, 2007 the Board of Supervisors approved Resolution No. 07-62 (item C-15) to allow for the involuntary detention, evaluation, and treatment of certain mentally disordered persons as specified in Welfare and Institution Code, Section 5150 at Sempervirens Psychiatric Health Facility located in Eureka, California.

The resolution before the Board today continues authority to designate the Sempervirens facility as the County's designated "5150" involuntary detention facility per Welfare and Institutions Code Section 5150, and expands the County's designated "5150" facility listing to include Psychiatric Emergency Services (PES). PES provides emergency psychiatric services. Additionally, the Resolution provides authorization to provide involuntary detention, evaluation, and treatment to certain mentally disordered minors at Sempervirens or PES, pursuant to Welfare Institution Code Sections 5585.50 and 5585.55. Pursuant to California Code of Regulations, Title 9 Section 821, the County must advise the State Department of Health Care Services of its designated facilities for evaluation and treatment purposes and designation of those persons who may, upon probable cause, take, or cause to be taken, a mentally disordered person or minor into custody and placement in the evaluation and treatment facilities.

Under the proposed resolution, individuals authorized to issue a 5150 5585.50 or a 5585.55 "hold" include Humboldt County peace officers, emergency room physicians, various licensed Department of Health and Human Services-Mental Health staff members, community psychiatrists who are Board certified as specified in the attached resolution, and physicians offering emergency services at K'ima:w Medical Center. The proposed resolution also adds the class of Physician's Assistant to those Department of Health and Human Services-Mental Health staff members with authority to issue a 5150, 5585.50, or a 5585.55 "hold."

The previous resolution, No. 07-62 passed by the Board of Supervisors July 24, 2007, should be rescinded because the new resolution will supersede the old one.

FINANCIAL IMPACT:

With passage of this resolution there is no anticipated impact to the County General Fund or the Mental Health Fund.

Approving this resolution supports the Board's Strategic Plan by continuing to provide opportunities for improved health and safety, and by protecting vulnerable populations.

OTHER AGENCY INVOLVEMENT:

Local hospitals, community psychiatrists, and physicians serving the K'ima:w Medical Center

ALTERNATIVES TO STAFF RECOMMENDATIONS:

Pursuant to Welfare and Institutions Code Section 5150, 5585.50, and 5585.55, the Board must have a resolution in place designating its facilities. The Board may choose not to approve Sempervirens and

Psychiatric Emergency Services as its facilities; however, this alternative is not recommended as mentally disordered patients would need to be treated at out-of-county facilities away from their local community and at additional cost. Additionally, there would not be a local facility to evaluate and treat mentally disordered minors.

RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS

PROVIDING EVALUATION SERVICES FOR MENTALLY DISORDERED PERSONS AND MINORS

WHEREAS, Welfare and Institutions Code Section 5150 provides for the involuntary detention, evaluation, and treatment of certain mentally disordered persons and Welfare and Institutions Code Sections 5580.50 and 5585.55 provide for the involuntary detention, evaluation, and treatment of certain mentally disordered minors; and

WHEREAS, Welfare and Institutions Code section 5404 authorizes counties to designate facilities as 72-hour evaluation and treatment facilities; and

WHEREAS, the County is required to advise the State Department of Health Care Services (California Code of Regulations, Title 9 Section 821) of its designated facilities for evaluation and treatment purposes and designation of those persons who may, upon probable cause, take, or cause to be taken, a mentally disordered person or minor into custody and placement in the evaluation and treatment facilities; and

NOW, THEREFORE, BE IT RESOLVED:

 The following named facilities are hereby designated as evaluation facilities for the purpose of the detention, evaluation, and treatment of mentally disordered persons and minors under this resolution:

Sempervirens - Eureka, CA Psychiatric Emergency Services - Eureka, CA

- The following classes of persons are hereby designated as persons who may, upon probable cause, take, or cause to be taken, mentally disordered persons and minors described in Welfare and Institutions Code Sections 5150 and 5585.50 into custody and place them into a facility.
 - a. Peace officers exercising jurisdiction within either the County of Humboldt or any incorporated city within the County.
 - b. On-duty emergency room physicians at any of the hospitals offering emergency room services in Humboldt County (in coordination with Sempervirens staff).
 - c. The following on-duty staff members of the Humboldt County

- i. Licensed physicians;

- v. Licensed physician's assistants
- vi. Licensed nurse practitioners;
- vii. Registered Nurses;
- viii. Licensed psychiatric technicians; and

- d. Community psychiatrists in Humboldt County who are certified by the Board of Medical Quality Assurance in the field of psychiatry.
- e. Licensed physicians offering emergency services at the K'ima:w Medical Center.

designated "5150" facility (Involuntary Detention Facility per Welfare and Institutions Code 5150.

Pursuant to WIC Section 5150, the County must also provide a list of persons and/or agencies who, according to law, can be authorized to "upon probable cause take, or cause to be taken," a person meeting the Lanterman-Petris-Short Act (LPS) detention criteria, into custody and place him or her into a designated treatment facility.

Under the resolution currently in place, individuals authorized to issue a "5150" include Humboldt County peace officers, emergency room physicians, the County Mental Health Branch Director, various licensed Mental Health Branch staff members, and community psychiatrists who are Board certified as specified in the attached resolution.

The proposed resolution also adds the class of Nurse Practitioner to those Mental Health Branch staff members with authority to issue a "5150" if so indicated. The previous resolution, #03-17, passed by the Board of Supervisors on February 11, 2003, should be rescinded because the new resolution will supersede the old one.

FINANCIAL IMPACT:

With passage of this resolution there is no anticipated impact to the County General Fund or the Mental Health Fund.

OTHER AGENCY INVOLVEMENT:

Local hospitals, community psychiatrists, and physicians serving the K'ima:w Medical Center.

ALTERNATIVE TO STAFF RECOMMENDITION:

Pursuant to WIC Section 5150, the Board must have a resolution in place. The Board could choose not to designate Sempervirens as the local 5150 facility. However, this alternative is not recommended as mentally ill patients would need to be treated at out-of-county facilities at additional cost. The Board could also choose to add or delete different categories of individuals as those authorized to take a person and place him/her in a mental health treatment facility.

PROVIDING EVALUATION SERVICES FOR MENTALLY DISORDERED PERSONS

WHEREAS, Welfare and Institutions Code, Section 5150 provides for the involuntary detention, evaluation, and treatment of certain mentally disordered persons; and

WHEREAS, the County is required to advise the State Department of Mental Health (California Code of Regulations, Title IX, Sections 821 and 821.1) of its designated facility for evaluation purposes and designating those persons who may, upon probable cause, take, or cause to be taken, a mentally disordered person into custody and placement in the evaluation facility;

NOW THEREFORE, IT IS RESOLVED as follows:

 The following named facility is hereby designated as an evaluation facility for the purpose of the detention, evaluation, and treatment of mentally disordered persons under this resolution:

Sempervirens - Eureka, CA

- The following classes of persons are hereby designated as persons who may, upon probable cause, take, or cause to be taken, mentally disordered persons described in Welfare and Institutions Code, Section 5150 into custody and place them into a facility.
 - Peace officers exercising jurisdiction within either the County of Humboldt or any incorporated city within the County.
 - On-duty emergency room physicians at any of the hospitals offering emergency room services in Humboldt County (in coordination with Sempervirens staff).
 - c. The following on-duty staff members of the Humboldt County Department of Health and Human Services Mental Health Branch Department or onduty Contractors credentialed by the Humboldt County Department of Health and Human Services Mental Health Branch Medical Staff as directed by the Mental Health Branch Director and approved by the County Board of Supervisors:
 - Licensed physicians;
 - ii. Licensed psychologists;
 - iii. Licensed clinical social workers;
 - iv. Licensed marriage, family and child counselors
 - v. Nurse practitioners;

vi. Registered nurses;

vii. Licensed psychiatric technicians; and

viii. Licensed vocational nurses;

- Community psychiatrists who are certified by the Board of Medical Quality Assurance in the field of psychiatry.
- Licensed physicians offering emergency services at the K'ima:w Medical Center.
- The designations under this resolution are effective the date herein stated above as approved by the Humboldt County Board of Supervisors. All previous designations are hereby revoked.
- The Clerk of the Board is authorized and directed to send certified copies of this
 resolution to the Mental Health Branch Director and the State Director of Mental
 Health.
- Resolution 03-17 is hereby rescinded.
