## Descriptions:

1. Total ICE Administrative Detainers Received – This is the total number of Administrative detainers received by ICE requesting a hold and release information. The majority of these requests are sent by fax to the Humboldt County Correctional Facility ***(A copy of any detainers received are forwarded to the inmate along with notification on whether or not the department intends to provide the information to ICE. Information is only provided to ICE on individuals whom have qualifying offenses pursuant to Government Code 7282.5)***
2. Detainers Received w/Qualifying Offenses – This is the number of individuals whom, upon researching their criminal history after receiving an Administrative Detainer, have a qualifying offense pursuant to Government Code 7282.5. ***(Criminal history is not researched on those individuals who were released prior to receiving the Administrative Detainer)***
3. Number of Individuals Released Prior to Receiving Detainer – This is the number of individuals that were already released from custody prior to the facility receiving the administrative detainer.
4. ICE interviews Requested (in person or by telephone) – This is the number of ICE interviews requested by ICE for an individual in custody ***(Prior to being interviewed anyone in custody will be given an ICE Interview Request form, in their chosen language, explaining their right to refuse the interview or have their attorney present)***
5. Provided Release Dates to ICE – This is the number of individuals that ICE was provided the release date for. ***(In all case where ICE is given an individual's release date the individual is notified in writing that the information was provided to ICE. In addition the information is also provided to a designee of the individual's choice if requested. Release dates are public information and are also provided to the general public upon inquiry)***
6. Individuals Turned Over to ICE – This is the number of individuals with qualifying offenses that were turned over to ICE on their release date. ***(No inmates are prevented from bailing or kept beyond their release date based on an Administrative Detainer)***
7. Number of Individuals with Qualifying Offenses in Custody – This is the number of inmates from the reporting year that have qualifying offenses pursuant to Government Code 7282.5 and are still in custody.
