**WHEREAS**, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

**WHEREAS**, on February 10, 2026 the Board of Supervisors adopted Resolution No. 26-10, providing for the implementation of the 2025-2026 Memorandum of Understanding for the Humboldt Deputy Sheriffs' Organization Unit 6; and

**WHEREAS**, the Board of Supervisors intends to amend the 2025-2026 Memorandum of Understanding for the Humboldt Deputy Sheriffs' Organization Unit 6; and

**WHEREAS**, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED** That the Board of Supervisors:

1. Adopt the amended classification specification for Deputy Sheriff Recruit (classification # 0418) into the classification system effective the pay period following board approval; and
2. Adopt the amended classification specification for Deputy Sheriff I/II (classification # 0416A/B) into the classification system effective the pay period following board approval.
