#### SUBJECT:

### DISCUSSION:

The Humboldt County Civil Grand Jury investigates and reports on the operations, accounts, and records of the officers, departments, or functions of the County of Humboldt and other local government agencies. The county thanks the grand jury for its hard work and efforts they have put forth in their 2023-24 Grand Jury reports. To date, the Humboldt County Civil Grand Jury has submitted eight reports to the Presiding Judge of the Superior Court, of which six pertained to the County of Humboldt and were received, and one report that requires responses from your Board will come before your Board today.
