DISCUSSION:

The FFY 2016 grant is an extension of the FFY 2003 through FFY 2015 grants provided by the Department of Homeland Security. Previous "terrorism-related" grants in 1999 through 2002 were provided by the Federal Emergency Management Agency and by the Department of Justice. The state Office of Homeland Security distributes the funding with assistance from the state Office of Emergency Services. Local government funding, approximately eighty percent of the total, will be dispersed to all fifty-eight California counties as grantees. Each county emergency services office is responsible for managing the grant process at the local government level.

The table below shows the amounts received by Humboldt County in past years.

Since the inception of the terrorism grant process in FFY1999, Humboldt County's first responder agencies have been allocated a total of \$4,573,621. The FFY 2015 grant is active through May 2018 and the Federal Government will award California Homeland Security-related funding in the amount of \$212,099 for FFY 2016, bringing the total amount awarded to Humboldt County since 1999 to \$4,785,720.

Homeland Security Grant funding will be utilized for equipment purchases and other grant activities for area fire, police, and first responder agencies throughout the county, beginning around November 2016, or when the application is approved, and will continue through May 2019, when the performance period ends. This is a one hundred percent reimbursement grant, with no match.

FINANCIAL IMPACT:

The county anticipates an allocation in the amount of \$212,099 for FFY 2016-2019, that will be applied to budget unit 1100-213-525320. All authorized expenditures of Homeland Security Grant funds are one hundred percent reimbursable with no match required.

Oversight of the Homeland Security Grant is coordinated by the OES Manager, as part of the Sheriff's Office emergency services program. An allowance of five percent or \$10,605 is

included in the allocation for management and administrative costs. There will be no impact on the General Fund.

The recommended action supports the Board's Strategic Framework Plan by seeking outside funding sources to meet Humboldt County's needs and create opportunities for improved health and safety

ALTERNATIVE TO STAFF RECOMMENDATIONS:

The Board may choose not to accept the grant funding. This is not recommended as the grant provides funding for many agencies throughout the county that would otherwise be unable to purchase necessary equipment and training.
