Recommend that the Board of Supervisors adopt by resolution a policy establishing a Humboldt County Vehicle Miles Traveled (VMT) CEQA threshold of significance and screening criteria for new development projects, to comply with California Senate Bill 743.

A motion by Commissioner Sarah West, seconded by Commissioner Peggy O'Neill to adopt resolution 25-025 proposing Vehicle Miles Traveled Threshold Policy Guidelines as presented with the changes made by the commissioners including inserting reference to the CAPCOA Handbook with the caveat that the Commission was deadlocked on what the baseline VMT should be and recommend the VMT Threshold Policy Guidelines be referred to the Board of Supervisors.
