- a. *56.5.2 Applicability. These regulations shall apply in Neighborhood Commercial (C-1), Community Commercial (C-2), Industrial Commercial (C-3), Highway Service Commercial (CH), and Business Park (MB) (ADD FOLLOWING LANGUAGE) [where the property is served by public water and sewer service including service from a Community Services District. In these Zones not served by public water and sewer a Special Permit is required.]*
- b. *56.5.3.3.1 Exceptions to Parking Standards. Parking standards for new residential units allowed as a commercial residential development shall not apply if the commercial residential development is located within one-half (1/2) mile walking distance of public transit with a clear path of travel and connection with appropriate pedestrian and bicycle facilities, (REMOVE FOLLOWING LANGUAGE) [and consists entirely of affordable housing units with covenants and restrictions ensuring long term affordability.]*

Attachment 4: Coastal Commercial Residential Ordinance adding section 313-56.5 and amending the tables in sections 313-2.1, 313-2.2, 313-3.1 in Chapter 3 of Division 1 of Title III of the County Code for the coastal areas of the County. [Attachment 4]

- a. *56.5.2 Applicability. These regulations shall apply in Neighborhood Commercial (CN), Commercial General (CG), and Business Park (MB) where the property is served by public water and sewer service including service from a Community Services District. In these Zones not served by public water and sewer a Special Permit is required.*
- b. *56.5.3.3.1 Exceptions to Parking Standards. Parking standards for new residential units allowed as a commercial residential development shall not apply if the commercial residential development is located within one-half (1/2) mile walking distance of public transit with a clear path of travel and connection with appropriate pedestrian and bicycle facilities, (REMOVE FOLLOWING LANGUAGE) [and consists entirely of affordable housing units with covenants and restrictions ensuring long term affordability.]*
