**RESOLUTION FOR EXCEPTION TO THE 180-DAY WAIT PERIOD FOR TEMPORARY EMPLOYMENT OF RETIRED ANNUITANT**

**WHEREAS**, the employment shall be limited to 960 hours per fiscal year for all CalPERS employers; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

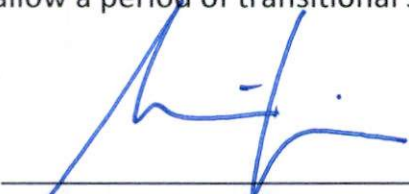
**WHEREAS**, the maximum base salary for this position is \$8,626.80 and the hourly equivalent is \$49.77, and the minimum base salary for this position is \$6,723.60 and the hourly equivalent is \$38.79; and

**WHEREAS**, the hourly rate paid to Curtis Eikerman will be \$49.77; and

**WHEREAS**, Curtis Eikerman has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** the County of Humboldt hereby certifies the nature of the appointment of Curtis Eikerman as described herein and detailed in the attached agenda item "Resolution for an Exception to the 180-Day Wait Period for Temporary Employment of Retired Annuitant as Operations Manager with Humboldt County Department of Aviation" hereby certifies the nature of the appointment and that this appointment is necessary to fill the critically needed position of Aviation Operations Manager by July 6, 2026, due to Mr. Eikerman's unique knowledge, skills and abilities required to support the delivery of services as provided by the Humboldt County Department of Aviation. This appointment will allow a period of transitional support for the newly hired Aviation Operations Manager.
