FIRST AMENDMENT MEMORANDUM OF UNDERSTANDING BY AND BETWEEN COUNTY OF HUMBOLDT AND

WESTSIDE COMMUNITY IMPROVEMENT ASSOCIATION FOR FISCAL YEARS 2021-2022 THROUGH 2024-2025

This First Amendment to the Memorandum of Understanding dated December 15, 2021, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Westside Community Improvement Association, a California nonprofit corporation, hereinafter referred to as "WCIA" is entered into this 22 day of 5000, 2022.

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Public Health, desired to work collaboratively with WCIA to conduct public COVID-19 testing and/or vaccination operations; and

WHEREAS, on December 15, 2021, COUNTY and WCIA entered into a Memorandum of Understanding regarding the performance of COVID-19 testing and/or vaccination operations at WCIA's facility located at 1000 B Street, Eureka, California; and

WHEREAS, the parties now desire to amend certain provisions of the Memorandum of Understanding in order to extend the term thereof through June 30, 2025.

NOW THEREFORE, the parties mutually agree as follows:

- 1. Section 2 Term of the Memorandum of Understanding is hereby amended to read as follows:
 - 2. <u>TERM</u>:

This MOU shall begin on December 2, 2021 and shall remain in full force and effect until June 30, 2025, unless sooner terminated as provided herein.

Except as modified herein, the Memorandum of Understanding dated December 15, 2021 shall remain
in full force and effect. In the event of a conflict between the provisions of this First Amendment and
the original Memorandum of Understanding, the provisions of this First Amendment shall govern.
