**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT APPROVING THE GENERAL PLAN AMENDMENT AND ZONE RECLASSIFICATION PETITION APPLICATION FOR FILE NUMBER APNS 033-041-038; 033-091-025, -026, -027, -033, -034 & -035; 033-101-001, -002, -003, -004, -005, -006, -007, -008, -010, -011, -015, -021, -022, -028, -029, -031, -032, & -035 CASE NUMBER PLN-2020-16218**

**WHEREAS**, Section 312-50.2 of the Humboldt County Code (HCC) allows the Board of Supervisors to initiate, grant, deny, or modify proposed amendments to Zoning Regulations; and

**WHEREAS**, Section 312-50.4 HCC allows a property owner to petition the Board of Supervisors to initiate a zone reclassification; and

**WHEREAS**, Section 312-50.5.2 HCC requires that the petition demonstrate that the change will be in the public interest and consistent with the General Plan; and

**WHEREAS**, Section 312-50.6 HCC specifies that a petition for amendment of the text or the zoning maps of the Zoning Regulations may also be initiated in conjunction with a petition for a General Plan amendment; and

**WHEREAS**, a petition for amendment of the General Plan may be accepted for processing by the Board of Supervisors upon making one or more of the findings in Chapter 3, Governance, Policy G-P8; and

**WHEREAS**, the petition to accept an application for general plan and zone reclassification is not a project as defined in Section 21065 of the Public Resources Code and is not subject to CEQA

**NOW, THEREFORE, BE IT RESOLVED** by the Humboldt County Board of Supervisors that the following findings are hereby made:

1. There is factual evidence in support of the petition for general plan and zone reclassification; and
2. The petition is in the public interest and is consistent with the General Plan.

**BE IT FURTHER RESOLVED** that based on the above findings, the findings in the staff report, evidence in the file for the project, and public testimony received on the project, the Board of Supervisors accepts the Benbow General Plan and Zone Reclassification Petition as recommended by the Planning and Building Department, Case No. PLN-2020-16218; and




