Project Locations

1. **PLN-12009-CUP, The Southerners of Humboldt LLC:** The project is located in Humboldt County, in the Whitethorn area, on the west side of Duty Ridge Rd, approximately 5 miles NNE from the intersection of Mattole Canyon Creek Rd and Duty Ridge Rd, on the property known to be in Township 03S of Range 02E Section 20 Humboldt Base & Meridian also known Ettersburg and as situs 7006 Doody Ridge Rd Whitethorn, CA 95589.
2. **PLN-11008-SP, Zion Carl:** The project is located in Humboldt County, in the Ettersburg area, on the North and south sides of Lower Thomas Road, at the intersection of Lower Thomas Road and B Road, on the property known to be in Section 25 of Township 03 South, Range 02 East, Humboldt Base & Meridian.
3. **PLN-10542-CUP, Garrett Gradin:** The project is located in Humboldt County, in the Garberville area, on the southwest side of Old Briceland Road, approximately 2.4 miles from the intersection of Briceland Thorne Road and Old Briceland Road, on the property known to be in Section 30 of Township 04 S, Range 03 E, Humboldt Base & Meridian.
