RESOLUTION NO. 24 –

A RESOLUTION APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2023-2024 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT PRESERVATION AND REINVESTMENT INITIATIVE FOR COMMUNITY ENHANCEMENT PROGRAM

WHEREAS, the Department of Housing and Urban Development (HUD) issued a Notice of Funding Opportunity (NOFO) on February, 28 2024, for the 2023-2024 Preservation and Reinvestment Initiative for Community Enhancement (PRICE) program to allocate up to \$235 million to communities to preserve and revitalize manufactured housing units; and

WHEREAS, the County of Humboldt, a political subdivision of the State of California, wishes to apply for and receive an allocation of funds through the PRICE program in the amount of \$5,000,000; and

WHEREAS, The HUD funding is made available to assist in the repair, rehabilitation and replacement of existing manufactured homes, as well as, provide for infrastructure improvement and resilience activities to benefit low- and moderate income residents; and

WHEREAS, On March 29, 2024, the Humboldt County Planning and Building Department held a properly noticed public meeting to describe available funding and eligible uses; and

WHEREAS, the County of Humboldt proposes to use the funds, if allocated, for: repair, rehabilitation, or replacement of existing manufactured housing units; development or improvement of infrastructure that supports new or existing MHCs and/or manufactured housing units, including roads, sidewalks, water, and wastewater infrastructure including well and septic systems, and utility hookups; environmental improvements such as remediation of contaminants; resident and community services, including relocation assistance and eviction prevention; and resilience activities, which include the reconstruction, repair, or replacement of manufactured housing and MHCs, as well as that for infrastructure serving MHCs, to enhance their safety and stability in the face of natural hazards.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED by the Humboldt County Board of Supervisors as follows:

 Directs Humboldt County Planning and Building staff to prepare and submit the grant application package to the Department of Housing and Urban Development to provide manufactured home preservation and revitalization funding in the amount of Five Million Dollars (\$5,000,000.00).
