SUPPLEMENTAL BUDGET REQUEST FOR THE AGRICULTURAL COMMISSIONER

## RECOMMENDATION(S):

That the Board of Supervisors:

- 1. Approve the Agricultural Commissioner's Supplemental Budget request for Fiscal Year 2014/15 totaling \$36,300.00 (4/5 vote required), and
- 2. Direct the Auditor Controller to execute the attached Supplemental Budget.

## SOURCE OF FUNDING:

California Department of Food & Agriculture (CDFA), Department of Pesticide Regulation (DPR)

## **DISCUSSION**:

In accordance with California Food and Agriculture Code (FAC Sections 224(a), 224(c) and 224(d) and Section 12844), the Agricultural Commissioner's Office receives annual revenue subventions from the CDFA and DPR to offset local costs for implementing State-mandated programs. Fiscal year (FY) 2014/15's Unclaimed Gas Tax reimbursement is \$16,249.00 more than anticipated, and the County's portion of the Pesticide Mill Assessment is \$20,051.00 more than allocated in the adopted FY 2014/15 budget.
