# PERSONAL IMPACT 3-MINUTE STATEMENT FOR 12/03/2024 HEARING

In June of 2023, my life changed drastically for the worst, when my 16 year old dog and I were startled awake at 9 pm by extreme noise and light flooding into my house. My house was rattling and shaking.

I live at Ground Zero, as the neighbors refer to my property, which borders the flood plain zoned property of Kernen Construction at Noisy Creek. After absolutely not one minute of sleep and scared dogs all night, I spoke with Scott Farley and begged him not to work nights and he said no & offered to send me on a vacation. I gave Scott Farley the page from his CUP with operating hours highlighted. I declined his vacation offer and figured the only way to be close to home was to stay at Blue Lake Casino Hotel with my dogs, for some 13 nights. We packed up each night & headed to the Hotel, returning to home in a.m. It was no vacation, believe me.

Now it's been 1 ½ years of blatant disregard for operating hours. Night time mechanics, quads, trucks, banging, vibrating my whole house and yard, etc., etc. have been a constant cause of sleep deprivation, stress & anxiety.

I have forwarded/emailed to the County approximately 50 dates and times of CUP Violations in 2023 & 2024. October 2023, pictures of Mechanics working at night to October 2024, Sheriff Boyer Incident Report of Mechanics working outside of CUP operating hours. October 15, 2024, I once again had to leave my house because Kernen had heavy equipment running all night, right across the creek from my bedroom window. This violation also witnessed/heard by Cindy Trobitz & Jarl Johansen. Maybe the County could request Kernen Construction's Employee Time Sheets. Recently the vibrations have shook my house until I thought the windows would break or concrete would crack, yet more violations. Jarl Johansen, across the street, could feel the vibrations.

Then there's the daily noise, dust and environmental devastation, clearing creek setback of riparian vegetation, unpermitted fencing, unpermitted pond, and unpermitted grading, Water Board Violations, THIRD Clean Water Act Complaint thru CATS organization. CATS has never had to file more than one complaint against any company before! Everything shows Kernen's blatant disregard for any laws, rules or regulations, let alone courtesy to neighbors. Kernen is worse than a Nuisance Code, Kernen is a nightmare, reeking havoc on our neighborhood and on the Coho Salmon Spawning Creek.
