RESOLUTION NO. 19-93

RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS SETTING THE TAX RATES FOR FISCAL YEAR 2019-2020

WHEREAS, the Board of Supervisors of the County of Humboldt is required by California Government Code Sections 29100, *et seq.* to set the secured tax rates for the County of Humboldt and school districts, special districts and other entities within Humboldt County as provided by Article XIII A of the California Constitution and Sections 93 and 100 of the California Revenue and Taxation Code.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Humboldt sets the tax rates for fiscal year 2019-2020 which it is required by law to set at the rates specified herein.

BASIC AD VALOREM TAX RATE

The County shall levy an ad valorem property tax on taxable assessed value of property within the County of Humboldt at a tax rate of \$1.00 per \$100.00 of assessed value (as the terms "tax rate" and "assessed value" are defined in Section 135 of the California Revenue and Taxation Code). The revenue from such tax shall be distributed in accordance with the provisions of California Revenue and Taxation Code, Division 1, Part 0.5, Chapter 6 and other applicable laws.

**ADDITIONAL TAX RATES FOR GENERAL OBLIGATION BONDS
OR OTHER INDEBTEDNESS**

The following tax rates are in addition to the \$1.00 per \$100.00 of assessed value tax rate levy set for the above for the purpose of making annual payments for interest and principal on general obligation bonds or other indebtedness of the local agencies and school districts in the County of Humboldt:
