## FIRST AMENDMENT TO UNIFORMED SCREENING PERSONNEL SERVICES AGREEMENT

This is the first amendment to the Uniformed Screening Personnel Services Agreement entered into on June 26, 2018, (the "Agreement") by and between Securitas Security Services USA, Inc., with an address at 1606 Koster Street, Suite A, Eureka, CA 95501, (CONTRACTOR), and the County of Humboldt, a political subdivision of the State of California (COUNTY), collectively "the Parties." The effective date of this Amendment is July 1, 2019.

## RECITALS

Whereas, COUNTY, through its Sheriff's Office, and CONTRACTOR entered into an Agreement for uniformed screening personnel services on June 26, 2018 with a start date of July 1, 2018; and

Whereas, COUNTY recently published a Request for Proposals for the provision of security screening services in the Humboldt County Courthouse and is in the process of evaluating the responses; and

Whereas the existing Agreement will expire on June 30, 2019; and

Whereas, the parties now desire to modify the term of the Agreement to allow the Agreement to continue while the COUNTY completes the Request for Proposal process and arrives at a contract for the provision of security services.

NOW, THEREFORE, IT IS AGREED as follows:

- 1. Section 11. TERM OF AGREEMENT, allows for one (1) one-year option to renew the Agreement. The Agreement is hereby renewed for a period of one year commencing on July 1, 2019, and ending on June 30, 2020, unless otherwise terminated as provided in the Agreement.
- 2. Section 12, TERMINATION, remains unchanged. The parties affirm that COUNTY may terminate the Agreement, as amended, for convenience at any time and for any reason pursuant to Section 12, B which states, "At any time and for any reason, COUNTY may terminate this Agreement, by giving sixty (60) days written notice to CONTRACTOR."
- 3. Except as modified herein, the Agreement shall remain in full force and effect. In the event of a conflict between the provisions of this amendment and the original agreement or a previous amendment, the provisions of this Amendment shall govern.

Each person executing this Amendment represents and warrants that he or she is duly authorized and has legal authority to execute and deliver this Amendment. Each party represents and warrants to the other that the execution and delivery of this Amendment and the performance of such party's obligations hereunder have been duly authorized.
