County of Humboldt's Behavioral Health Department has the Transitional Age Youth Program with five clinicians seeking to complete the Eye Movement Desensitization and Reprocessing Therapy (EMDR) training and certification process they have begun with funding from the County of Humboldt. EMDR is primarily used to treat trauma, depression, obsessive-compulsive disorder (better known as OCD), and substance abuse.

Original EMDR funding has been expended and the county faces debit, so the youth-focused clinicians are not likely to receive more funding to complete the training and are seeking funding to complete the remaining 20 hours, each of training to complete EMDR certification. Five Transitional Age Youth (TAY) clinicians will work in one group to receive training completion from a EMDR consultant. The applicant confirmed the EDMR consultant is neither local, nor a person who identifies as BIPOC.

Funding is needed by February 2024.

TAY addresses multiple, simultaneous vulnerabilities in Humboldt County, CA and Hoopa, CA. They serve Transitional-Age Youth, hence the acronym for their branch for County of Humboldt Behavioral Health services. They serve people ages 16 through 26, who must meet one additional of the following requirements beside the age requirement: they must be in foster care, extended foster care, the juvenile justice system, or within three years of their first psychosis diagnosis.

In 2022, 35% of people TAY served self-identified as being BIPOC.

In 2022, 6% identified as transgender or nonbinary.
