**POST-ADOPTION  
SUMMARY OF  
ORDINANCE**

On June 27, 2023, the Humboldt County Board of Supervisors adopted Ordinance No. 2716, which amends the zoning of property in the Briceland area, through immediate conversion approximately 4.8 acres of Timberland Production Zone (TPZ) into Forestry Recreation with a 40-acre minimum parcel size (FR-B-5(40)), approximately 4.8 acres of Unclassified (U) into Timberland Production Zone (TPZ) and approximately 79 acres of Unclassified (U) into Forestry Recreation with a 40-acre minimum parcel size (FR-B-5(40)). The new zones will become effective thirty (30) days after the date of adoption. The names of the Supervisors voting for and against are as follows:
