WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

- Adopt the new job classification of Child and Family Administrative Manager (classification # 1801, salary range 502) into the classification plan effective the pay period following board approval;
- 2. Adopt the new job classification of Child and Family Support Program Manager (classification # 1802, salary range 502) into the classification plan effective the pay period following board approval;
- 3. Adopt the Resolution approving the amendment of the January 1, 2022 December 31, 2024, Compensation Plan for Designated Management and Confidential Employees; and
- 4. Adopt the Comprehensive Compensation Schedule and Classification Summary effective March 3, 2024.
