WHEREAS, the aforesaid conditions of extreme peril continue to exist and necessitate the continued proclamation of the existence of a Local Emergency; and

WHEREAS, while the Humboldt County Code indicates that the frequency of emergency proclamation review should be every 30 days, it also states that the frequency of review shall be in accordance with Government Code section 8630 which provides for review every 60 days.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED that said Local Emergency shall be deemed to continue to exist throughout said county as prescribed by state law, and by ordinance and the Humboldt County Code, and resolutions of this county, and by the County of Humboldt Emergency Operations Plan, as approved by the Board of Supervisors on April 7, 2015, until its termination is proclaimed by the Board of Supervisors of the County of Humboldt, State of California.
