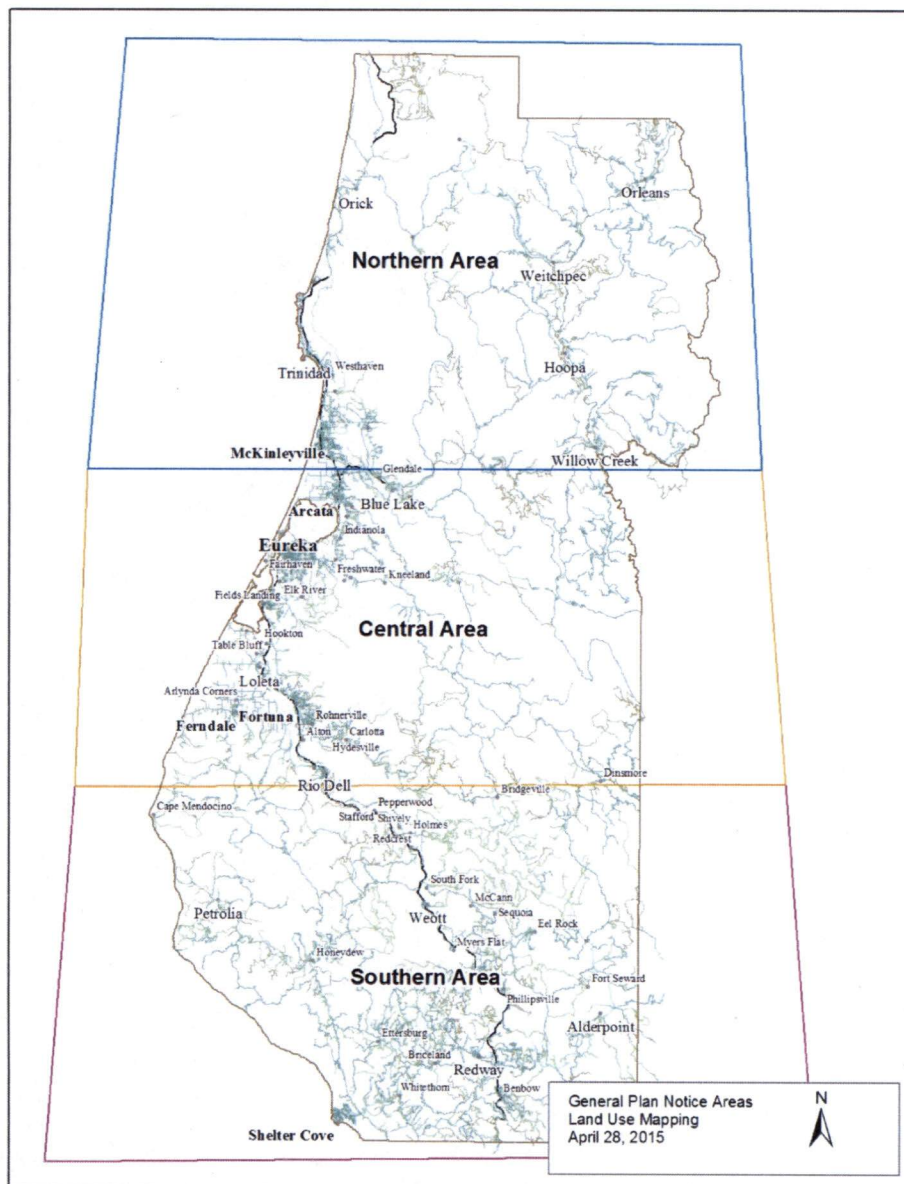
DISCUSSION:

Land Use Mapping Workshops and Meetings

At the July 27th meeting the Board deliberated on the maps for the Central Area. Staff will verbally summarize the results of that meeting at the August 17th public hearing. Attachments 1 and 2 of this staff report present the parcel-specific straw votes from the first two mapping meetings which considered the Northern and Central Areas. A supplemental staff report will be provided documenting the land use requests for the Northern and Southern Areas that have not yet been considered by the Board.

The figure below shows the different GPU mapping areas.

Figure 1. Land Use Mapping Workshop and Meeting Areas



The recommended procedure for completing review of the Northern and Southern Area maps during the public hearing is the same general procedure used at the previous meetings, and it involves the following steps:

- 1) Public comment / Board deliberation / straw vote on the proposed changes to the Northern Area map areas that were not already considered by the Board:
 - a. Map #5 Willow Creek North
 - b. Map #6 Willow Creek South
 - c. Map #7 McKinleyville
 - d. Map #8 Fieldbrook
 - e. Map #9 Arcata Bottoms
 - f. Map #10 Arcata East
 - g. Map #11 Blue Lake/Glendale
 - h. Other Northern Area land use requests not already considered by the Board.
- 2) Public comment / Board deliberation / straw vote on the proposed changes to the Southern Area map areas that were not already considered by the Board.
- 3) Public comment on Central Area properties. (Note: this is a courtesy public comment time for those unable to attend the future continued public hearing for the Central area.)

GPU Review Schedule

Attachment 3 is the updated draft schedule for completion of the remaining GPU tasks for review, comment and modification.

FINANCIAL IMPACT:

The cost of preparing this staff report is borne by the General Fund through the Planning and Building Department, Advance Planning Division's FY 2015-2016 budget, and the General Plan User Fees Trust Fund 3698.

OTHER AGENCY INVOLVEMENT:

The General Plan Update program has been a multi-year project. Multiple agencies have been involved in the review and preparation of the Planning Commission approved Draft General Plan. The County has been in communication with the Planning Commissioners, County Counsel and the County Administrator's office on the transmittal of these draft documents.
