# RESOLUTION OF THE ZONING ADMINISTRATOR OF THE COUNTY OF HUMBOLDT

#### **Resolution Number 24-**

PLN-2023-18118 (CUP-06-30/SMP-06-01/RP-06-01) Assessor's Parcel Number 223-136-003; 223-136-004

MAKING THE REQUIRED FINDINGS FOR CERTIFYING COMPLIANCE WITH THE CALIFORNIA ENVIORNMENTAL QUALITY ACT AND CONDITIONALLY APPROVING THE EXTENSION OF CONDITIONAL USE PERMIT, SURFACE MINING PERMIT AND RECLAMATION PLAN

WHEREAS, agents for Wallan Quarry submitted an application and evidence in support of approving a renewal of Wallan Quarry SMARA Permit consisting of Conditional Use Permit, Surface Mining Permit, Reclamation Plan, and Financial Assurance. The applicant proposes to continue mining and processing. Average annual extraction not to exceed 15,000 cubic yards (cy) of gravel and

WHEREAS, the County Planning Division has reviewed the submitted application and evidence and has referred the application and evidence to involved reviewing agencies for site inspections, comments and recommendations; and

WHEREAS, A Subsequent Mitigated Negative Declaration was adopted on December 18, 2008 by the Humboldt County Planning Commission for the surface mining permit and no changes to the mining operation are proposed as part of this renewal; and; and

WHEREAS, Attachment 2 in the Planning Division staff report includes evidence in support of making all of the required findings for approving the proposed extension of the permits for the surface mining operation and reclamation plan, and financial cost assurance estimate; and

WHEREAS, on July 18, 2024 a duly noticed public hearing was held to receive public testimony on the proposed project.

**THEREFORE BE IT RESOLVED,** that the Zoning Administrator makes all the following findings:

### 1. FINDING:

**Project Description:** The Wallan Quarry Renewal is a renewal of a 15-year term of a previously approved, existing rock quarry (CUP-06-30/SMP-06-01/RP-06-01). The project is an existing aggregate quarry extracting run-of-mine hard rock aggregate that was approved in 2008. Rip-rap, road base, road surface materials and buttress material are hauled directly to construction sites. No changes are proposed to the existing approvals, site plan, limits of excavation, methods, equipment, plan of operation or end use.

**EVIDENCE:** a) Project File: PLN-2023-18118

## 2. FINDING:

**CEQA:** The project is within the scope of the 2008 CEQA Subsequent Mitigated Negative Declaration that was adopted by the Humboldt County Planning Commission.

**EVIDENCE:** a) No expansion horizontally or vertically is proposed; no changes are proposed.

b) The project was previously modified with conditions of approval and through CEQA review mitigation measures were incorporated and remain part of the project.

Mining Permit 15-Year Renewal (*Title III, Div. 9, Chapter 1, §391-4(b)(6), Term,* of the Humboldt County Code)

3. FINDING:

The life expectancy of the operation justifies a 15-year renewal.

**EVIDENCE:** a)

The applicant states that quarry reserves contain more aggregate material than can be extracted from it over the next 15-year term.

4. FINDING:

There are no special circumstances related to the operation that would cause the term to be set for less than 15 years.

**EVIDENCE:** a)

Referral notices were sent to interested agencies and no agencies indicated that the term should be less than 15 years.

5. FINDING:

The mine has been conducted in compliance with permit conditions.

**EVIDENCE:** a)

The operation is inspected annually by County Planning staff for compliance with the Reclamation Plan and conditions of approval and mitigation measures. The most recent inspection report from November 2023 shows no violations or issues.

6. FINDING:

Original conditions of approval remain in effect.

**EVIDENCE:** a)

a) There are no known changes in the law or circumstances that would preclude a 15-year renewal.

## **DECISION**

**NOW, THEREFORE**, based on the above findings and evidence, the Humboldt County Zoning Administrator does hereby:

- 1. Adopt the findings set forth in this resolution; and
- 2. Approves the Conditional use Permit renewal subject to the conditions of approval in Attachment 1A.
