RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IMPLEMENTING COST OF LIVING ADJUSTMENTS SCHEDULED FOR THE FIRST FULL PAY PERIOD IN JANUARY 2024 EARLY EFFECTIVE DECEMBER 24, 2023, FOR THE CALIFORNIA ATTORNEYS' ASSOCIATION UNIT 5 AND ADOPTING A COMPREHENSIVE COMPENSATION SCHEDULE AND CLASSIFICATION SUMMARY.

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on March 1, 2022, the Board of Supervisors adopted Resolution No. 22-26, providing for the adoption of the 2022-2024 Memorandum of Understanding for the California Attorneys' Association Unit 5; and

WHEREAS, the Board of Supervisors desires to implement the three (3) percent COLAs scheduled for the first full pay period in January 2024, early effective the pay period beginning December 24, 2023, for all classifications in the California Attorneys' Association Unit 5; and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:

1. The three (3) percent COLAs scheduled for the first full pay period in January 2024, shall be implemented early effective the pay period beginning December 24, 2023, for all classifications in the California Attorneys' Association Unit 5.
2. Resolution No. _____ (Attachment 2) is approved amending the Memorandum of Understanding (MOU) between the County of Humboldt and County Attorneys Association (CAA) for Unit 5.
3. The December 24, 2023, Comprehensive Compensation Schedule and Classification Summary is adopted.
