RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DISTRICT ATTORNEY'S OFFICE TO APPLY FOR, AND ACCEPT, FUNDING MADE AVAILABLE BY THE BOARD OF STATE AND COMMUNITY CORRECTIONS THROUGH THE ORGANIZED RETAIL THEFT VERTICAL PROSECUTION GRANT

WHEREAS, the County of Humboldt ("County"), by and through the Humboldt County District Attorney's Office desires to participate in the Organized Retail Theft Vertical Prosecution Grant Program ("HCDA ORTVP") administered by the Board of State and Community Corrections ("BSCC").

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Humboldt County District Attorney's Office is hereby authorized and directed to apply for and, if awarded, accept HCDA ORTVP Program funds in accordance with any and all applicable local, state and federal laws, regulations, requirements and standards.
- 2. The Humboldt County District Attorney, or a designee thereof, is hereby authorized to conduct any and all negotiations, and enter into, execute and deliver any and all documents, including, without limitation, applications, agreements, amendments, certifications and attestations, required, or deemed necessary, to apply for, accept and secure HCDA ORTVP Program funding made available by BSCC.
- 3. If the County's application for HCDA ORTVP Program funding is approved by BSCC, the County hereby represents and certifies that all such HCDA ORTVP Program funding will be used in a manner consistent, and in compliance, with any and all applicable local, state and federal laws, regulations, requirements and standards, including, without limitation, any and all applicable laws, regulations, requirements and standards regarding the HCDA ORTVP Program, as well as any and all applicable agreements between the County and BSCC.
- 4. If the County's application for HCDA ORTVP Program funding is approved by BSCC, the County hereby represents and certifies that such HCDA ORTVP Program funding will not be used to supplant expenditures controlled by the County.
