WHEREAS, the Board of Supervisors desires to implement the two (2) percent COLAs scheduled for the first full pay period in January 2023, early effective December 25, 2022, for all classifications in Elected and Appointed Department Heads (Units 10 and 11); and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:

- The two (2) percent COLAs scheduled for the first full pay period in January 2023, shall be implemented early effective the pay period beginning December 25, 2022, for all classifications in Elected and Appointed Department Heads (Units 10 and 11).
- Resolution No. 22-189 is approved amending the Compensation Plan between the County of Humboldt and Elected and Appointed Department Heads (Units 10 and 11).
- 3. The amended December 25, 2022 Comprehensive Compensation Schedule is adopted.
