**ORDINANCE NO. \_\_\_\_ - \_\_\_\_ INCORPORATING BY REFERENCE APPENDIX O OF THE 2019 CALIFORNIA BUILDING CODE, AND APPENDIX X OF THE 2019 CALIFORNIA RESIDENTIAL CODE TO SECTION 331-11 OF CHAPTER 1, DIVISION 3 OF TITLE III OF THE HUMBOLDT COUNTY CODE, RELATING TO EMERGENCY HOUSING STANDARDS.**

The Board of Supervisors of the County of Humboldt ordains as follows:

**SECTION 1. PURPOSE.**

The California Legislature passed AB 2553 (2020) requires the adoption and application of Emergency Housing Standards for emergency shelters developed under a Shelter Crisis Declaration on county-owned and county-leased land, and the Emergency Housing Standards Ordinance (Attachment 8) incorporates these standards by reference as Appendix O of the California Building Code and Appendix X of the California Residential Code into Section 331-11 of Title III, Division 3 of the Humboldt County Code

**SECTION 2. INCORPORATION OF EMERGENCY HOUSING BY REFERENCE**

Section 331-11 in Chapter 1 of Division 3 of Title III of the Humboldt County Code, which incorporates Uniform Building Codes by reference, is hereby amended and added to as follows (additions are shown in underline text; deletions are shown in ~~striketrough~~):

**331-11. Incorporation of Uniform Codes by Reference.**

Each of the following compilations, except as modified hereinafter, are hereby designated and adopted by reference as a part of this chapter with the same force and effect as if they were set out in full herein:

(a) *California Building Code and Building Code Standards*. 2019 California Building Code, Volumes 1 and 2 and their respective successor provisions.

(7) Appendix O, relating to Emergency Housing, is incorporated by reference.

(n) *California Residential Code*. 2019 California Residential Code.

(1) Appendix X, Emergency Housing, is incorporated by reference.

**SECTION 3. EFFECTIVE DATE**

This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the
