

**SECOND AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES  
BY AND BETWEEN  
COUNTY OF HUMBOLDT  
AND  
NICHOLS, MELBURG & ROSSETTO ARCHITECTS  
For the County of Humboldt Juvenile Hall Replacement Facility Construction Project

This Second Amendment to the Agreement for Professional Services dated June 27, 2017, as amended on November 16, 2018, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Nichols, Melburg & Rossetto Architects, a California corporation, hereinafter referred to as "CONSULTANT," is entered into this 22<sup>nd</sup> day of Nov., 2019.

WHEREAS, COUNTY, by and through its Department of Public Works, desired to retain a qualified professional to provide architectural and design engineering services related to the replacement of the County's existing Juvenile Hall with a new full service, medium-maximum security Juvenile Hall facility ("Project"); and

WHEREAS, on June 27, 2017, COUNTY and CONSULTANT entered into an Agreement for Professional Services regarding the provision of architectural and design engineering services for the Project ("Professional Services Agreement"); and

WHEREAS, on November 16, 2018, COUNTY and CONSULTANT amended the Professional Services Agreement in order to extend the term thereof and allow for the provision of additional architectural, design engineering and construction administration services thereunder; and

WHEREAS, the parties now desire to further amend certain portions of the Professional Services Agreement in order to extend the term thereof and adjust the rates of compensation set forth therein.

NOW, THEREFORE, it is mutually agreed as follows:

1. Section 5.1 of the Professional Services Agreement is hereby amended to read as follows:
  - 5.1 The term of this Agreement shall begin as of April 8, 2014 and shall remain in full force and effect for a period of two thousand four hundred twenty (2,420) calendar days, unless sooner terminated as provided herein.
2. CONSULTANT shall provide additional services consistent with those described in Section 8 of Appendix B "Task #7: Construction Phase" of the Professional Services Agreement beyond the originally anticipated number of days as an additional service. The term of these additional services will be an additional three hundred sixty-five (365) calendar days from the effective date of this Second Amendment, and be compensated on a Lump Sum basis per Section 2.6 of Appendix C with a guaranteed maximum price not to exceed Two Hundred Seventy-Five Thousand Seventy Dollars (\$275,070.00).
3. Except as modified herein, the Professional Services Agreement dated June 27, 2017, as amended on November 16, 2018, shall remain in full force and effect. In the event of a conflict between the provisions of this Second Amendment and the original Professional Services Agreement, or any prior amendments thereto, the provisions of this Second Amendment shall govern.

IN WITNESS WHEREOF, the parties hereto have entered into this Second Amendment to the Professional Services Agreement dated June 27, 2017, as amended on November 16, 2018, as of the first date written above.


