## RESOLUTION IN HONOR AND RECOGNITION OF THE LIFE OF FORMER HUMBOLDT COUNTY SHERIFF GENE WHEELER COX

**WHEREAS**, Former Humboldt County Sheriff, Gene W. Cox, passed away on November 29, 1982 just four weeks before he was to retire; and

**WHEREAS**, Officer Cox began his police career with the Arcata Police Department in the early 1950's; and

WHEREAS, in 1954 Officer Cox joined the Humboldt County Sheriff's office; and

**WHEREAS**, in 1962 Officer Cox became the Undersheriff due to his professional and personal demeaner. He was well respected in the department; and

**WHEREAS**, Officer Cox was elected in 1966 as the County of Humboldt Sheriff and was re-elected in 1970, 1974 and 1978; and

**WHEREAS**, Officer Cox chose not to seek re-election as he was planning his retirement. It was four short weeks before his retirement that he was shot and killed in the line of fire.

**WHEREAS,** Officer Cox is remembered as the man whose laugh you could hear ringing across the building.

**NOW, THEREFORE, BE IT RESOLVED** that the Humboldt County Board of Supervisors wishes to honor the life and legacy of former Humboldt County Sheriff Gene W. Cox and wholeheartedly supports the naming of a section of State Route Highway 101 in his memory.
