RESOLUTION IN HONOR AND RECOGNITION OF THE LIFE OF EUGENE B “JOE” THOMAS

WHEREAS, Eugene “Joe” Bertram Thomas was born on April 2, 1924, in Eureka; and

WHEREAS, Mr. Thomas graduated from Eureka High School in 1942 and while in high school learned to fly at Pierce Flying School at Murray Field; and

WHEREAS, Mr. Thomas attended one semester at Humboldt State College in 1942 before joining the United States Army in 1943; and

WHEREAS, Mr. Thomas became a pilot of the B-24 Liberator in the 15th Air Force of the United States Army, stationed in Italy in World War II; and

WHEREAS, Mr. Thomas and his crew were shot down over Yugoslavia and spent 41 days trapped behind enemy lines, the final crew of The Forgotten 500 to be rescued on December 28, 1944; and

WHEREAS, Mr. Thomas was assigned a position flying for the OSS after the war; and

WHEREAS, Mr. Thomas returned to Humboldt County in 1945 to resume life as a civilian, and attended Humboldt State College before graduating from Stanford University with a degree of Civil Engineer; and

WHEREAS, Mr. Thomas began a lifetime career at the California State Division of Highways, later named CalTrans; and

WHEREAS, Mr. Thomas engineered spans of Highway 101 up and down Humboldt, Del Norte, and Mendocino counties; and

WHEREAS, Mr. Thomas and his family moved from Eureka to Sacramento in 1969, when he was promoted to headquarters for CalTrans, eventually rising to Chief Maintenance Engineer for the entire state; and

WHEREAS, Mr. Thomas exemplified the Greatest Generation: service, patriotism, strength of character, hard work, generosity, and resilience, and it is therefore appropriate to designate a portion of US Highway 101 in honor of Eugene “Joe” B. Thomas.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby requests that a portion of US Highway 101 (postmile 86.50 to postmile marker 89.00 near Arcata) in the County of Humboldt be designated as the Eugene B “Joe” Thomas Memorial Highway.
