**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING HUMBOLDT COUNTY INTERIM DIRECTOR OF AVIATION, OR A DESIGNEE THEREOF, TO EXECUTE ANY AND ALL DOCUMENTS RELATED TO FEDERAL AVIATION ADMINISTRATION, INFRASTRUCTURE INVESTMENT AND JOBS ACT (IIJA) AIRPORT INFRASTRUCTURE GRANT (AIG) GRANT NO 3-06-0010-063-2025**

**WHEREAS**, the County of Humboldt has a need to improve the planning, safety, and infrastructure for its six-airport system;

**WHEREAS**, the Humboldt County Department of Aviation submitted a Project Application to the FAA for a grant of federal funds for California Redwood Coast-Humboldt County Airport (ACV) acquisition of Aircraft Rescue and Fire Fighting (ARFF) vehicle;

**WHEREAS**, the FAA has approved said project for the California Redwood Coast-Humboldt County airport;

**WHEREAS**, pursuant to and for the purpose of carrying out the Title 49, United States Code (U.S.C.), Chapters 471 and 475; 49 U.S.C. §§ 40101 et seq., and 48103; FAA Reauthorization Act of 2018 (Public Law Number 115-254); the Department of Transportation Appropriations Act, 2021 (Public Law 116-260, Division L); the Consolidated Appropriations Act, 2022 (Public Law 117-103); and the representations contained in the Project Application; and in consideration of: (a) the Sponsor's adoption and ratification of the Grant Assurances attached hereto; (b) the Sponsor's acceptance of this Offer; and (c) the benefits to accrue to the United States and the public from the accomplishment of the Project and compliance with the Grant Assurance and conditions as herein provided; the Federal Aviation Administration has allocated to Humboldt County Department of Aviation funding that has been made available through the Airport Improvement Program.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County Interim Director of Aviation and/or Assistant County Administrative Officer, or a designee thereof, is hereby authorized to conduct any and all negotiations, and enter into, execute and deliver any and all documents, including, without limitation, agreements, amendments and payment requests, required, or deemed necessary, to accept and secure an allocation of funding made available through the US Department of Transportation on Infrastructure Investment and Jobs Act (IIJA) Airport Infrastructure Grant (AIG) Grant Number 3-06-0010-063-2025.
2. If the Humboldt County Interim Director of Aviation and/or Assistant County Administrative Officer, or a designee thereof, agrees to accept funding made available through the Infrastructure Investment and Jobs Act (IIJA) Airport Infrastructure Grant Program, the County hereby represents and certifies that the County will only utilize these funds for any purpose for which airport revenues may be lawfully used pursuant to the FAA's Policy and Procedures Concerning the Use of Airport Revenues.
