Subject: Advance Salary Request for Samanthia Carns, Recordable Document Examiner I (4/5 Vote Required)

## **RECOMMENDATION(S)**:

1. Approve an advance salary step for Recordable Document Examiner I, Step 1A, Samanthia Carns, to Recordable Document Examiner I, Step B, retroactive to date of hire on October 20, 2014, pursuant to Section 7 of the Humboldt County Salary Resolution (4/5 vote required).

# SOURCE OF FUNDING: 1100 General Fund

<u>DISCUSSION</u>: Samanthia Carns was hired by the County Clerk / Recorder on October 20<sup>th</sup>, 2014 with the understanding the she would come in at a salary level commensurate with her pay as a Court Legal Process Clerk I at the salary level of \$13.28 per hour. In addition to Ms. Carns experience with the courts, she has immeasurable experience and knowledge in the County Clerk / Recorder's office having worked in an extra-help position from 2007 to 2012. During Ms. Carns time in the County Clerk / Recorder's office, she has acquired and gained vast knowledge of the process and functions of the department. Ms. Carns brings efficiency and skill to the department which greatly benefits the county.

On January 6, 2015, your Board took action to approve an advance salary request for Ms. Carns, agenda item C-11. However, due to a clerical error the recommendation did not contain the appropriate language to make this advance salary request retroactive to Ms. Carns' start date. This language is now included in this agenda item. The County Administrative Office can process advanced salary requests prior to an employee's start date. Due to an oversight by the department, this request was not submitted and is now

#### FINANCIAL IMPACT:

The placement of Ms. Carns at an advanced step will not have a significant financial impact. The position was vacated in late June after the submission of the 2013-14 budgets and was previously filled by an employee at Salary Step E. Because the position was not filled until October, and because Ms. Carns is coming in at a lower step, there will be an estimated overall salary savings of \$13,465.00 for this fiscal year. Hiring an employee with the knowledge and experience of the department has also saved the county indirect costs of training and use of other staff time.
