Resolution by the Planning Commission of the County of Humboldt certifying compliance with the California Environmental Quality Act and denies the American Hospital Management Corp Conditional Use Permit application.

WHEREAS, American Hospital Management Corp submitted an application and evidence on December 30, 2016 in support of approving a Conditional Use Permit for 10,000 square feet of new Mixed Light commercial cannabis cultivation; and;

WHEREAS, the applicant has not provided requested materials to complete the application and has not provided written response to requests for additional application materials; and

WHEREAS, the project is statutorily exempt from environmental review pursuant to Section 15270 of the State CEQA Guidelines (projects which are disapproved); and

WHEREAS, the Humboldt County Planning Commission held a duly-noticed public hearing on April 20, 2023, and reviewed, considered, and discussed the application for a Conditional Use Permit and reviewed and considered all evidence and testimony presented at the hearing.

Now, THEREFORE BE IT RESOLVED, that the Planning Commission makes all the following findings:

1. FINDING: Project Description: Conditional Use Permit for 10,000 square feet

of new Mixed Light commercial cannabis cultivation

**EVIDENCE:** a) Project File: CUP-16-1052

2. FINDING: CEQA. The requirements of the California Environmental Quality

Act have been complied with. The project is statutorily exempt from

CEQA as it is a project which is not approved.

**EVIDENCE:** a) Section 15270 of the CEQA Guidelines.

## FINDINGS FOR CONDITIONAL USE PERMIT

**3. FINDING** The proposed development is not consistent with the requirements of

the CMMLUO Provisions of the Zoning Ordinance and all applicable

standards and requirements of these regulations.

**EVIDENCE** a) Section 314-55.4.8 of the Humboldt County Code (CMMLUO) identifies the allowable zone districts where commercial cannabis cultivation may occur. The AV zone, which is the applicable zone district for the property, is not listed as an eligible zone district.

## **DECISION**

**NOW, THEREFORE,** based on the above findings and evidence, the Humboldt County Planning Commission does hereby:

Denies the Conditional Use Permits and Special Permits for American Hospital Management Corp.
