**RESOLUTION NO. 24 –**

**RESOLUTION TO ACCEPT THE RIGHTS OF WAY FOR LYNNEA COURT FOR PUBLIC ROAD PURPOSES AND FOR PUBLIC SIDEWALK EASEMENT PURPOSES**

**WHEREAS**, Section 66477.2 of the Government Code authorizes the Board of Supervisors by resolution to rescind its action and accept the offer of dedication on a map and open the streets, paths and alleys, and right-of-way easements to the public; and

**WHEREAS**, an offer of dedication to the County of Humboldt of Lynnea Court for public road purposes; and Underwood Road for public road purposes; Parcel D for 20-foot pedestrian and drainage easement purposes; Parcel E for stormwater drainage facility purposes; and Parcel P for 5-foot pedestrian easement purposes was made on Tract Map No. 0603 by Daniel Morgan; and

**WHEREAS**, On December 11, 2007, the Humboldt County Board of Supervisors did not accept the offer of dedication of Lynnea Court for public road purposes; and Underwood Road for public road purposes; Parcel D for 20-foot pedestrian and drainage easement purposes; Parcel E for stormwater drainage facility purposes; and Parcel P for 5-foot pedestrian easement purposes; and

**WHEREAS**, On December 21, 2007, Tract Map No. 0603 was filed in Book 24 of Maps, pages 57, 58, & 59 in the office of the Humboldt County Recorder and is incorporated herein by reference; and

**WHEREAS**, County now desires to accept the dedication of Lynnea Court for public road purposes and for public sidewalk easement purposes; Parcel D for 20-foot pedestrian and drainage easement purposes; and Parcel P for 5-foot pedestrian easement purposes; and

**WHEREAS**, County is not accepting Underwood Road at this time; and

**WHEREAS**, Parcel E has been accepted by McKinleyville Community Services District (MCSD) for stormwater drainage purposes and will be maintained by MCSD therefore will not be included in this division; and

**WHEREAS**, Sidewalks within and fronting the subdivision will not be maintained by the County. Pursuant to Resolution 21-39, adopted by the Board of Supervisors on April 20, 2021, maintenance of sidewalks is the responsibility of the fronting landowner.

The acceptance of the dedication shall be effective upon the recordation of the resolution in the office of the County Recorder.
