DISCUSSION: Supervisory Ryan Sundberg currently serves as the Member on the North Coast Emergency Medical Services Board and Susan Buckley, Public Health Director serves as the Alternate. Susan is proposing a shift of the Alternate representative on the NCEMS Board to Public Health Officer Dr. Alan Baird. She believes the NCEMS JPA will benefit from Dr. Baird's active participation on the Medical Advisory Committee of the EMCC, as well as his role as a primary care provider in the community. As the designated Medical Health Operational Area Coordinator, the Health Officer works with EMS to organize and coordinate appropriate responses in an emergency. Dr. Baird's presence at the JPA as the Alternate would help assure needed familiarity with Humboldt's pre-hospital response system.
