ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT AMENDING SECTIONS 421-2, 421-3, 421-5 RELATING TO STOP INTERSECTIONS, AMENDING SECTIONS 422-7, 422-9, 422-10, 422-11, 422-12 RELATING TO SPEED LIMITS, AND ADDING SECTION 431-97.5 RELATING TO PARKING, ALL IN THE SCOTIA AREA ,TO TITLE IV OF THE HUMBOLDT COUNTY CODE

ORDINANCE NO. 2536

The Board of Supervisors of the County of Humboldt do ordain as follows:

SECTION 1. Sections 421-2, 421-3 and 421-5 of Chapter 1 of Division 2 of Title IV of the Humboldt County Code are amended as shown on the attached pages.

SECTION 2. Sections 422-7, 422-9, 422-10, 422-11 and 422-12 of Chapter 2 of Division 2 of Title IV of the Humboldt County Code are amended as shown on the attached pages.

SECTION 3. Section 431-97.5 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code is added as shown on the attached page.

SECTION 3. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.
