SUBJECT:

Ratification of Appropriation Transfer in the Amount of \$50,000 for Special Investigations Fund

RECOMMENDATION(S):

That the Board of Supervisors:

1. Ratify the appropriations transfer in the amount of \$50,000 for Drug Task Force budget 3644-265 for the Special Investigations.

STRATEGIC PLAN:

This action supports the following areas of your Board's Strategic Plan.

Area of Focus: Safe & Healthy Communities

Strategic Plan Category: 1001 - Support and sustain partnerships between public safety and partner agencies to enhance public safety in our communities

DISCUSSION:

In accordance with government code 29430-29441, the county Board of Supervisors (BOS) shall establish a Sheriff's special appropriation that may be used for expenses in criminal cases arising in the county. Historically, this special appropriation was budgeted in the Drug Task Force (DTF) budget 3644-265 in line-item Special Investigations. It is funded by asset forfeiture fees distributed to DTF. Due to prior Auditor-Controller direction, the line item was eliminated, and the appropriations were budgeted in 2123 Special Departmental over the past 5 years.

This account has recently been re-reviewed and new guidance from the current Auditor-Controller has recommended that the appropriations be transferred back to Special Investigations object code 2611 for greater transparency. In accordance with the government code, since the BOS shall establish the appropriation, this item is being brought to your board for ratification. Moving forward the appropriations will be budgeted in 2611 Special Investigations as part of the annual budget submission process.
