

**AGREEMENT FOR  
CDF HUMBOLDT-DEL NORTE UNIT USE  
OF SHERIFF'S OFFICE GENERATOR**

**Background:**

The CDF Humboldt-Del Norte Unit and the Humboldt County Sheriff's Office both support the efforts of the Southern Humboldt Emergency Preparedness Committee (SHEPC) to assist citizens in the Garberville area during emergency or disaster situations. The CDF Unit allows the SHEPC to use a room at the CDF Garberville Station for meetings and as a Command Post during activations. The Sheriff's Office provides legitimacy to the SHEPC through the Office of Emergency Services for them to act as an organizational entity supporting County OES actions and as an informational conduit within, to, and from the Garberville area. Both the CDF Unit and the Sheriff's Office provide the SHEPC with material, organizational, and training support as needed.


The SHEPC, the CDF Unit, and the Sheriff's Office have determined that a back-up power source is needed to ensure full-time operation of the Command Post. The Sheriff's Office has procured a generator for use at the Garberville Station. The trailer-mounted generator will be loaned to the CDF Unit which will assume all operational responsibilities for its use.

The CDF Humboldt-Del Norte Unit and the Humboldt County Sheriff's Office agree as follows:

1. The below identified trailer-mounted generator will be loaned to the CDF Unit by the Sheriff's Office:

Denyo MQ Power Whisperwatt 25  
25 kVA 14.4 kW AC Generator  
Model DCA25SSIU  
VIN: 4GNFU1017TB501091  
Year/Make: 11-96  
The generator shows 9359 hours operation.
2. The Sheriff's Office will license the generator trailer with an Exempt CA plate.
3. The CDF Unit may use the generator as it pleases provided the Garberville Station Command Post is accorded the top priority for its use when needed.
4. The CDF Unit will store the generator at the Garberville Station except for when it is needed for Unit operations elsewhere.
5. The CDF Unit will assume all responsibility for the generator including any hook-up installation, maintenance, upkeep, and repair costs.
6. There will be no financial obligation on the part of the Sheriff's Office for the CDF Unit's use of the generator.
7. The CDF Unit will hold-harmless the Sheriff's Office for its use of the trailer-mounted generator.

The CDF Humboldt-Del Norte Unit and the Humboldt County Sheriff's Office have caused this agreement to be executed.

RENEWAL FEES MUST BE PAID ON OR BEFORE THE REGISTRATION EXPIRATION DATE OR PENALTIES WILL BE DUE PURSUANT TO CALIFORNIA VEHICLE CODE SECTIONS 9552 - 9554.

EVIDENCE OF LIABILITY INSURANCE FROM YOUR INSURANCE COMPANY MUST BE PROVIDED TO THE DEPARTMENT WITH THE PAYMENT OF RENEWAL FEES. EVIDENCE OF LIABILITY INSURANCE IS NOT REQUIRED WITH REGISTRATION RENEWAL OF OFF-HIGHWAY VEHICLES, TRAILERS, VESSELS, OR IF YOU FILE A PNO ON THE VEHICLE.

WHEN WRITING TO DMV, ALWAYS GIVE YOUR FULL NAME, PRESENT ADDRESS, AND THE VEHICLE MAKE, LICENSE, AND IDENTIFICATION NUMBERS.
